Sir,

In producing herewith the following accd. persons namely, Nasir Khan@ Kali, s/o: Soleman Khan of Beliara, P.S. Bishnupur, Dist. Bankura along with a seized scooty (Chassis No. MD626DG3XD2L55016 and Engine No. OG3LD2218075), I, SI. Barnali Sarkar of Bishnupur P.S. would like to lodge a Suo- motto complaint against aforesaid accd. Person and others to the effect that today, as per schedule, I left the P.S. with force for performing NAKA checking duty within P.S. area. This refers Bishnupur P.S. GDE No.1260, dt. 29.01.19 and CC No. 470/19, Dt. 29.01.19.

I started NAKA checking at Katandhar More on Bishnupur - Armabag pitch road at 13:35hrs. Around 14:15hrs, I found a scooty without number plate, coming towards Katandhar more from Sonamukhi Bypass side at a tremendous high speed. On seeing Police, the driver cum solo rider tried to change the direction of scooty and tried to flee away. But alertness of my accompanying forces did the rest. The scooty along with its only rider cum driver was detained.

I asked the driver cum rider of said scooty to provide me with his full address and particulars and also asked him to show the documents of that scooty. He tried to befool me by providing his wrong name, address and particulars and showed his reluctance in terms of showing documents of the scooty, he was riding.

After a thorough interrogation, he gave me his name, address and particulars. I verified the same on spot with the help my sources and found those correct. Further, he stated that he is a professional motorcycle lifter and he has his motorcycle lifting team. He lifts motorcycle from Paschim Medinipur side - especially from Garhbeta and sells those in Durgapur and Hoogly. Besides, he works as a mediator in terms of disposing of stolen bikes and scooty. He stated that the scooty he was riding is also a stolen one and he was going to sell it. So, I seized the scooty under proper seizure list in between 14:25hrs to 14:45 hrs and arrested said Nasir Khan@ Kali, maintaining legal formalities.
