In producing herewith the following articles 1. Two core flexible wire of length approx- 08 (Eight) Mtr. with one nos 100 W lamp Seized under proper seizure list, duly signed by available witnesses, I MD Afroz Ahmad (34) S/O-MD Sayeed , Assistant Engineer & Station manager of Indpur CCC do hereby lodge complaint against 1. Sk. Mahuruddin(user), S/O of Sk. Arshad., Vill: Kadamkanali, PS: Indpur, Dist.: Bankura to the effect that today at 11.00 hrs acting on a tip-off, myself accompanied by 1. Sumit Kumar Misra , Sr. SAE(E) 2. Sitaram Banerjee , S.O. (S& LP) , Bankura Regional Office 3. Saroj Kumar Biswas, Hr. Sr. LM, Indpur CCC 4. Binod Rai , Sr. TSH, Indpur CCC had gone to Kadamkanali village to work out the information. Around 12.30 hrs of date we reached at Village Kadamkanali and started inspection the electric line near the house of Sk. Mahuruddin(user) and during inspection occupier cum house owner Sk. Mahuruddin(user) has been found stealing electricity dishonestly at his premises by way of direct hooking from LT line and has caused financial loss to WBSEDCL and the load is assessed as 100 W. On asked the house owner cum Occupier failed to given satisfactory reason for such action.

Thus the owner cum Occupier Sk. Mahuruddin(user) has violated the provision of section 135(1) (a) of Electricity Act 2003 (Amendment 2007).

Hence I seized the above noted articles under proper seizure list duly signed by available witnesses following disconnection the electric line by removing hooking device and produce before you with a request to initiate a case u/s 135(1) (a) of Electricity Act 2003 (Amendment 2007) against Sk. Mahuruddin(user), S/O of Sk. Arshad., Vill: Kadamkanali, PS: Indpur, Dist.: Bankura and arrange for its investigation.

The result of the investigation may kindly be communicated after its completion for onward action.
