I Sri, Ajit Kumar Kundu, S/O Sri Sudhir Chandra Kundu, A.E & Station Manager of Beliatare Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date do hereby lodge complaint Sri Debu Ruidas, S/O – LT Sajani Ruidas Vill-Muchipara, Baliatare, P.O- Beliatare, PS- Beliatare, Dist- Bankura for committing theft of Electricity dishonestly for his domestic purpose which is an offence under Section 135(1)(a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date .

On getting information today 23.07.2019 at about 12:50 PM, I along with 1) Sri Subhadeep Roy, S.A.E(E) 2) Alope Nath Karmakar, Hg Sr L.M, 3) Satyapada Roy, Hg TSH inspected the domestic premises of Sri Debu Ruidas, S/O – LT Sajani Ruidas, Vill-Muchipara, Baliatare P.O- Beliatare, PS- Beliatare, Dist- Bankura.

During inspection it was detected that Sri Debu Ruidas, S/O – LT Sajani Ruidas committed theft of Electricity dishonestly by direct hooking from nearby LTOH line of WBSEDCL for his domestic use for which WBSEDCL loss huge revenue. Detected load 0.24 KW.

Inspection report was prepared on spot. Accused and local public refused to sign.

I directed the technical staff to remove the hooking cable from LTOH line.

I seized some portion hooking cable with hooking device and prepare the seizure list. Accused and local public were asked for their signature but they refused.

we left the spot on at 01:20 PM.

It is well proved that the accused Sri Debu Ruidas, S/O-LT Sajani Ruidas is liable for prosecution as committed theft of electricity by direct Hooking under Section 135 (1)(a) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are hereby requested to take this complain, treat this letter as F.I.R to start a case for further investigation to arrest the accused to stop such revenue loss of WBSEDCL
