Dear Sir,

I Sri. Ajit Kumar Kundu, S/O Sri Sudhir Chandra Kundu, A.E & Station Manager of Bellatore
Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act
2017 as amended upto date do hereby lodge complaint Sri Ratan Rautas, S/O - Nara Rautas, Vill-
Muchipara, Bellatore P.O- Bellatore, PS- Bellatore, Dist- Bankura for committing theft of Electricity
deliberately for his domestic purpose which is an offence under section 135(1A) of Electricity Act, 2003 and
Electricity (Amendment) Act, 2017 as amended upto date.

On getting information today 23/07/2019 at about 11:25 PM, I along with 1) Sri Subhadreep Roy,
S.A.E(E), 2) Anwar Nath Garmakar, Hq Sr L.M J. Anwar Khatun Mondal Hq TSB, 4) Suryapada Roy, Hq
TSB inspected the domestic premises of Sri Sri Ratan Rautas, S/O - Nara Rautas, Vill-Muchipara,
Bellatore P.O- Bellatore, PS- Bellatore, Dist- Bankura.

During inspection it was detected that Sri Ratan Rautas, S/O - Nara Rautas committed theft of Electricity
deliberately by direct hooking from nearby LTCH line of WBSEDCL for his domestic use for which
WBSEDCL was huge revenue. Estimated cost 1.25 KW.

It is also noticed that there is a service connection vide con. no. 2017W0378 in deemed disconnected status (disc
date- 01.11.2018), passing out Rs. 2727.75.

Inspection report was prepared in spot with the LTI of Smt Kanaka Rautas (mother of accused) and local
public Sri Anir Rautas s/o - Laxman Rautas.

I directed the technical staff to remove the hooking cable from LTCH line.

I issued some portion hooking cable with hooking device and prepare the seizure list with the LTI of Smt
Kanaka Rautas (mother of accused). Local public were asked for their signature but they refused.
we left the spot on at 11:50 PM.

It is well proved that the accused Sri Ratan Rautas, S/O - Nara Rautas is liable for prosecution as
committed theft of electricity by direct hooking under Section 135 (1)(a) of Electricity Act, 2003 and
Electricity (Amendment) Act, 2017 as amended upto date.

You are hereby requested to take this complaint, treat this letter as F.R. to start a case for further
investigation to arrest the accused to stop such revenue loss of WBSEDCL.
