Sri Shyamal Kr Lai as BPM Junbedia Branch Postmaster is not authorized to issue such Pass book to public. But perhaps he has managed to the depositors and destroyed original Passbooks and settled their issues by his own capacity.

Apart from above Sri Shyamal Kr Lai GDSBPM Junbedia BO in his official capacity made withdrawal irregularly by way of manufacturing 20 (twenty) numbers of SB-7 (withdrawal) vouchers in respect following old age pension SB A/cs beyond the knowledge of the depositor and when the case was detected said Sri Shyamal Kr Lai repaid the amount to Old Age Pensioner

The activity from the part of said Sri Lai may kindly be treated as "Cognizable Offence" and considering all above, this Department urges for depth Inquiry into this case. Kindly lodge FIR against Sri Shyamal Kr Lai GDSBPM Junbedia (Now under Put Off duty) under relevant section of IPC.
