Sir,

In producing herewith the arrested accused person namely Sk Raju (28 Yrs) S/O- Sk Yusub of Kabbardanga, PS & Dist-Bankura along with seized articles (1) One country made improvised pipe gun (2) One round live ammunition. I ASI. Prasanta Kr. Sinha of Bankura PS do hereby lodge a written complainant to the effect that today (25.07.19) myself along with C/567 Sunil Das, C/1710 Sasti Charan Sinha and C/1772 Pradip Ch. Mahato of Bankura PS were engaged to perform road mobile duty vide Bankura PS CC No. 1685/19 dt. 25.07.19 and Bankura PS GDE No. 1517 dt. 25.07.19 at Bikna area. At about 20.35 hrs received a credible source information that one Sk Raju (28 Yrs) S/O- Sk Yusub of Kabbardanga, PS & Dist-Bankura is moving at Keranibandh more area with a Fire Arms for commit any crime. I informed the matter to I/C, Bankura PS and as per direction I along with force proceeded to work out the information. At about 21.05 hrs reached at Keranibandh more and as per source information we managed to apprehended one person. On being asked he disclosed his name as Sk Raju (28 Yrs) S/O- Sk Yusub of Kabbardanga, PS & Dist-Bankura. After disclosing my identity and reason for search his body I searched of his person and one country made improvised pipe gun was recovered from his waist which loaded with one live ammunition. On asked he gave different statements in different times and he failed to give any satisfactory answer regarding kept the fire arms with him. He also failed to produce any document against the fire arms. In thoroughly interrogation he confessed that he is came there with fire arms to commit crime. Then I seized the fire arms in proper seizure list duly signed by the accused person in presence of Police witnesses and obtaining signature of Police witnesses in seizure list due to none local people agree to put signature on seizure list. After that I also arrested him after maintaining all formalities. After that the accused person with seized fire arms brought to PS and submitting complaint against accused person Sk Raju (28 Yrs) S/O- Sk Yusub of Kabbardanga, PS & Dist-Bankura with a prayer for start a specific case under arms Act.

So, I pray before you that one specific case may kindly be started against Sk Raju (28 Yrs) S/O- Sk Yusub of Kabbardanga, PS & Dist-Bankura, under proper section of Arms Act.
