Sir,

In producing herewith accused Debasish Adhurjya (45 years) S/o. Lt. Gunamoy Adhurjya of Maliara Kanyakubja Para P.S. Barjora Dist Bankura and following seized articles do here by lodge a written complaint to the effect that today (25.07.19) at 16.15 hrs in course of my mobile duty received a source information that one Debasish Adhurjya S/o. Lt. Gunamoy Adhurjya of Maliara Kanyakubja Para P.S. Barjora Dist Bankura is selling liquor in exchange of money at his Hotel namely Maa Manasa at Maliara Bye-pass Under Barjora P.S. After receiving this information I informed the matter to IC Barjora P.S and as per his direction I along with other and force left for Maliara Bye Pass to work out the information. On reaching there at 17.25 hrs I found that said Debasish Adhurjya is selling liquor in exchange of money at his Hotel namely Maa Manasa at Maliara Bye Pass. Then I asked him to produce valid license or documents for selling the liquor but he failed to produce any valid license or documents before me and failed to give any satisfactory answer regarding the selling of liquor. On being further asked he stated that he was selling liquor in exchange of money illegally since long. As such I seized the following articles from his possession after preparing proper seizure list and arrested him issuing memo of arrest after obtaining all legal formalities regarding arrest rule and N.H.R.C. During the time of arrest I informed to his brother Asish Adhurjya (aged about 42 years) I also prepared label of seized articles:-

Seized Articles

- (i) 17 (seventeen) bottles of country spirit 600 ml each in sealed condition styled as CAPTAIN, IFB agro industries limited (printed price Rs. 75/- each) of which one bottle country spirit taken out as sample and labeled.
- (ii) 04 (four) bottles of kingfisher (Bear) 650 ml each, printed price Rs. 125/- each in sealed condition of which one bottle kingfisher (Bear) taken out as sample and labeled.

So I pray that a specific case may kindly be started against said Debasish Adhurjya S/o. Lt. Gunamoy Adhurjya of Maliara Kanyakubja Para P.S. Barjora Dist Bankura under proper section of law and to arrange for its investigation.
