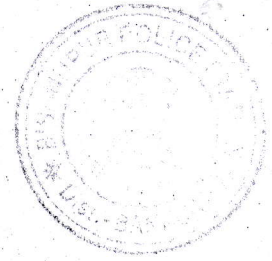

Sir,

In producing here with the accused namely Hari Bagdi (35 yrs) s/o Ganesh Bagdi of vill- Bhalukkhola PS- Bishnupur Dist -Bankura with seized 12(twelve) bottles of CAPTAIN country spirit 600 ml each under proper seizure list, I beg to submit that today [25.07.2019] myself along with C/1423 Md Jahangir, C/183 Debabrata Chowdhury, C/246 Debabrata Chatterjee in course of evening mobile duty vide Bishnupur PS GDE No- 1175 dt 25.07.19 and Bishnupur PS CC No- 2473/19 dt 25.07.19 received a secret source information that one person is selling liquor at his house at Bhalukkhola village under Bishnupur PS . Accordingly at about 18.55 hrs myself along with force rushed to Bhalukkhola village and found that the above noted accused person was selling liquors to the passers by customers in exchange of money and also stocking liquors inside his owned house there . We searched his house thoroughly and found 14(twelve) bottles of CAPTAIN country spirit 600 ml each. I asked him to produce the valid papers in respect of said liquor bottles but he failed to produce any valid documents in support of stocking and selling of liquors at his shop . So I seized above articles under proper seizure list in presence of witnesses . One bottle of each item was proper sealed and labelled as sample. As he is violated the provision of Bengal Excise Rule so I arrested him under 46 BE Act after maintaining all the formalities regarding arrest.

Under the above circumstances I pray that a case may kindly be registered against the arrested Hari Bagdi (35 yrs) s/o Ganesh Bagdi of vill- Bhalukkhola PS- Bishnupur Dist -Bankura u/s 46 of B.E. Act. for violation of Bengal Excise Rule .
