In Producing herewith the following seized articles (as per seizure list) and one arrested accused namely Ashim Dutta (33yrs) S/O Tarapada Dutta vill- Chhilimpur, PS-Bishnupur Dist-Bankura, and submitting a written complaint to the effect that on 25-07-2019 at about 20:30 hrs in course of mobile duty with C/479 Rajib Mahapatra, C/1366 Samir Kumar Roy of Radhanagar OP Under Bishnupur PS vide Radhanagar OP GDE no - 552 Dt 25-07-2019 Received a source information that one Ashim Dutta (33yrs) selling liquor at Prakashghat Bazar in his tea Stoll in lieu of money. After receiving this information I along with force rush to the spot. On seeing police vehicle some people escape from there. Somehow we managed to apprehend the above named person on being asked he failed to produce any valid document in respect of selling liquor in exchange of money. As such, I seized the following articles from the possession of Ashim Dutta (33yrs) S/O Tarapada Dutta of Vill-Chhilimpur, P.S-Bishnupur selling liquor at Prakashghat Bazar in his tea Stoll. After preparing proper seizure list duly signed by the witnesses and also arrested person, after that I arrested Ashim Dutta (33yrs) S/O Tarapada Dutta Vill- Chhilimpur P.O-Uliar P.S-Bishnupur after mentioning all legal formalities. I also prepared labeled of seized articles.

1. 10 (Ten) bottles Country Sprit (600 ml Each) styled as 'CAPTAIN' including 1 bottle as sample.

On the above notated Context I would therefore pray that a specific case in this respect may kindly be started against Ashim Dutta (33yrs) S/O Tarapada Dutta vill- Chhilimpur, PS-Bishnupur Dist-Bankura accused persons under proper section of law.
