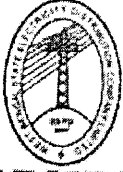

Sub: Complain against Gurupada Das, S/o Late Bhupen Das, Vill Kapista Namopara, P.O Kapista, PS GANGAJALGHATI for theft of Electricity by direct hooking from overhead Line of WBSEDCL.

Sir,

I Biswanath Dey, S/o Harekrishna Dey, aged about 32 years, A.E(E) & Station Manager, Gangajalghati ccc being authorized under the Electricity Act. 2003 and Electricity (Amendment) Act-2007, do here by lodge complaint against Gurupada Das, S/o Late Bhupen Das, Vill Kapista Namopara, P.O Kapista, PS GANGAJALGHATI Dist Bankura for theft of electricity for his domestic needs by direct hooking with the help of hooking device and pvc wire from nearby LTOH lines of WBSEDCL. So, Gurupada Das, S/o Late Bhupen Das, Vill Kapista Namopara, P.O Kapista, PS GANGAJALGHATI committed theft of electricity and liable for prosecution U/S.-135(i)(a) of Electricity Act 2003 and Electricity (Amendment) Act-2007.

On 29.07.2019 in between 16:15 Hrs. and 16:45 Hrs. myself along with (i) Ratan Gour, SAE(E), Gangajalghati CCC, ii) Sadhan Ch Pramanik, S/o Late Santiram Pramanik, Sr TSH. Gangajalghati CCC and others from Bankura Divisional office, on the basis of secret source of information inspected the domestic premises of Gurupada Das, S/o Late Bhupen Das, Vill Kapista Namopara, P.O Kapista, PS GANGAJALGHATI Dist- Bankura and found that said Gurupada Das was using electricity unauthorizedly and dishonestly in their domestic premises by direct hooking with the help of hooking device and PVC wire from nearby overhead line of WBSEDCL that causing huge loss of revenue of WBSEDCL. So Gurupada Das committed theft of electricity and liable for prosecution U/S.-135(i)(a) of Electricity Act-2003 and Electricity (Amendment) Act-2007.

The load was assessed as 0.400 KW by the inspection team and accordingly the inspection report was prepared. Then, I instructed Sadhan Ch Pramanik, Sr TSH. Gangajalghati CCC to disconnect the line and seized the hooking materials. He did the same. Accordingly, Ratan Gour, SAE(E), Gangajalghati CCC prepared the seizure list and I Seized the hooking materials. Our team left the site at about 16:45 Hrs.

So you are hereby requested to treat this complaint as F.I.R.
