Sir,

This is to inform you that I, Sadananda Pal, S/o- Sri Chandra Sekhar Pal, J.E. (Gr.- I) & Station Manager, Mejia Customer Care Centre, WBSEDCL, Balurghat, is hereby lodge a complaint against 1) Sri Lalmohan Mondal, S/O - Lt Narayan Chandra Mondal & 2) Sri Jayanta Mondal, S/O - Lt Narayan Chandra Mondal Vill Ardhamgram (Mondal Para), PO - Ardhamgram, PS -Mejia, Bankura under Mejia Police Station due to unauthorized use of electricity by means of direct hooking in his premises as per the provision of section 135 (i) (a) of the Electricity Act 2003 amendment in 2007. The detail is described below:

From authentic source we came to know that Sri Lalmohan Mondal is using electricity illegally at his Domestic premises at Ardhamgram (Mondal Para), PO - Ardhamgram, PS -Mejia. Then and there on 25.07.2019 at about 01.00 PM I along with 1) Sri Kanai Kundu, S/O Sri Nimai Kundu, J.E. (Gr. - II), 2) Sri Dipak Sharma, S/O - Lt Sudarshan Sharma, ACM and other technical staffs of Mejia CCC went to inspect the Domestic premises of Sri Jayanta Mondal and at the time of inspection we found that Sri Lalmohan Mondal was enjoying electricity in his premises unauthorisedly by means of direct hooking from nearest LTOH line of WBSEDCL causing huge revenue loss to the company.

After that seized the articles as per seizure list and left the premises at about 01.30 PM.

After that we went to the Domestic premises of Sri Jayanta Mondal at about 01.35 PM and at the time of inspection we found that Sri Jayanta Mondal was enjoying electricity in his premises unauthorisedly by means of direct hooking (Same hooking wire used which is used by Sri Lalmohan Mondal) from nearest LTOH line of WBSEDCL causing huge revenue loss to the company.

After that we disconnect the hooking line, seized the articles as per seizure list and left the premises at about 02.20 PM.

Thus accused Sri Lalmohan Mondal & Sri Jayanta Mondal are therefore liable for prosecution under section 135 (i) (a) of the Electricity Act 2003.

The seized articles are being handed over along with this FIR for further judicial formalities. You are requested to treat this complaint as FIR.
