Sir,

This is to inform you that I, Sri Sadananda Pal, S/o- Sri Chandra Sekhar Pal, J.E. (Gr.- I) & Station Manager, Mejia Customer Care Centre, WBSEDCL, ~~Mejia~~<sup>Mejia</sup>, is hereby lodge a complaint against Sri Dhananjoy Badyakar, S/O – Sri Anath Badyakar Vill Tewaridanga, PO – Dang Mejia, PS -Mejia, Bankura under Mejia Police Station due to unauthorized use of electricity by means of direct hooking in his premises as per the provision of section 135 (i) (a) of the Electricity Act 2003 amendment in 2007. The detail is described below:

According to source information we came to know that Sri Dhananjoy Badyakar is using electricity illegally at his Domestic premises at Vill Tewaridanga, PO – Dang Mejia, PS -Mejia. Then and there on 30.07.2019 at about 13:30 hrs I along with 1) Sri Sitaram Banerjee, Special Officer (S&LP), Bankura Regional Office, 2) Sri Kanai Kundu, S/O Sri Nimai Kundu, J.E. (Gr. - II), 3) Sri Dipak Sharma, S/O – Lt Sudarshan Sharma, ACM and other technical staffs of Mejia CCC went to inspect the Domestic premises of Sri Dhananjoy Badyakar and at the time of inspection we found that Sri Dhananjoy Badyakar was enjoying electricity in his premises unauthorisedly by means of direct hooking from nearest LTOH line of WBSEDCL causing huge revenue loss to the company.

After that we disconnect the hooking line, seized the articles as per seizure list and left the premises at about 14:00 hrs.

The seized articles are being handed over along with this FIR for further judicial formalities. You are requested to treat this complaint as FIR.
