Sir,

In producing herewith the arrested accused namely Asit Bauri (32) S/O Late Sankar Bauri with following seized articles under proper Seizure List. I, SI Bamdeb Sinha Patrasayer P.S beg to state you that today at about 18:55 hrs received a secret information that one Asit Bauri (32) S/O Late Sankar Bauri of Vill- Bamira under Patrasayer P.S has kept a huge quantity of illegal, ID liquor for sale in his house which is situated at Bamira under Patrasayer P.S. Dist- Bankura. Inform the matter to O/C Patrasayer PS and as per direction of O/C Patrasayer PS I along with C1464 Subhas Hambram .C/354 Swapan Kumar Murmu left for the said Village to work out the information. We reached at Bamira at about 19:35 hrs and as identified by secret source reached in the house of said Asit Bauri. Seeing police some persons fled away from the house The owner of the house Asit Bauri (32) S/O Late Sankar Bauri of Vill-Bamira under Patrasayer P.S failed to produce any kind of document or license in respect of storing and selling liquors and admitted that he is running such business from his house since long without any license. So I seized 30(Thirty litter Id liquor in three plastic jarican stored in his house. Accordingly I seized the three plastic Jarican containing 10 litter ID liquor each jarican under proper S/L duly signed by the accd. Person and available witnesses the seized articles were sealed and labeled at the spot. And arrested accused Asit Bauri (32) S/O Late Sankar Bauri of Vill-Bamira PS Patrasayer after maintain all rule of apex court Issue arrest memo with proper signature duly signed by witnesses and took my custody.

Under the above circumstances I request you to start a specific case against the accd Asit Bauri (32) S/O Late Sankar Bauri of Vill-Bamira PS Patrasayer Dist Bankura under proper section of law and arrange for its investigation.
