Sub: Lodging of FIR

Sir,

This is to inform you that, I, Md Abu Seena, S/O- Md Musaddeque Hossain, A.E & SM, Saltora CCC under Bankura (D) Division along with the Office team comprising of 1) Susanta Paramanik s/o-Dhirendranath Paramanik of Saltora CCC 2) Enzamam ul haque s/o- Mohammed Mansoor Alam & other technical staffs of Saltora CCC conducted a raid programme on 26th July, 2019 at about 13:00 hrs to 13:30 hrs in the premises of **Sri Sintu Bhadra S/o- Sri Muktipada Bhadra vill:- Shirpura P.O-Tiluri P.S-Saltora, Dist-Bankura**. During inspection it is found that **Sri Sintu Bhadra (Aadhar no.: 600589070067)** and his family members were enjoying electricity dishonestly by direct hooking from nearest Live LTOH Line. As a result of this WBSEDCL has incurred huge loss of revenue. After that we have disconnected the hooking line and also dismantled hooking wire along with hooking device. The contractual load of the disconnected connection was 0.5 KW and as a token of evidence we have seized following items:

1. PVC 2 core cable (approx 30 feet long) along with hooking device.

After detecting theft of electricity we have prepared the inspection report and then we have seized the articles as mentioned above. Thereafter we have prepared seizure list on spot & left his premises at 13:30 hrs.

So undersigned want to lodge a complaint against **Sri Sintu Bhadra S/o- Sri Muktipada Bhadra** U/s 135(i)(a) of electricity act, 2003 and as amended on 2007.

That theft causing huge loss to WBSEDCL and he is liable to prosecution under section 135 (i) (a) of the electricity act, 2003. This complaint may be treated as FIR.
