Dear Sir,

I Sri, Ajit Kumar Kundu, S/O Sri Sudhir Chandra Kundu, A.E & Station Manager of Beliatare Customer Care Centre, WBSEDCL being empowered by Electricity act 2003 and Electricity (Amendment) Act 2007 as amended upto date do hereby lodge complaint **Sri Samir Roy (user), S/O- Lt Madan Roy, Vill-KansabatiPara, Natungram, P.O- Beliatare, PS- Beliatare Dist- Bankura** for committing theft of Electricity dishonestly for his domestic purpose which is an offence under Section 135(1)(a)&(b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

On getting information today 24.09.2019 at about 12:15 PM, I along with 1) Sri Subhadeep Roy, J.E (Gr-II) 2) Alope Nath Karmakar, Hg Sr L.M 3) Satyapada Roy, Sr TSH,, 4) Sumanta Danguria TSH all from Beliatare CCC inspected the domestic premises of **Sri Samir Roy(user), S/O-Lt Madan Roy Vill-KansabatiPara, Natungram, P.O- Beliatare, PS- Beliatare Dist- Bankura**.

During inspection it was detected that **Sri Samir Roy (user), S/O-Lt Madan Roy** committed theft of Electricity dishonestly by bypassing the energy meter of existing permanent connection bearing consumer ID 200147059 by direct hooking from nearby LTOH line of WBSEDCL for his domestic use as a result the energy consumption was not recorded in the energy meter of WBSEDCL for which WBSEDCL loss huge revenue. Observed load 0.3 kW.

Inspection report was prepared on spot. Accused Sri Samir Roy was asked for signature but he left the spot. Jaysree Roy(w/o Samir Roy) and others local public refused to sign.

I directed the technical staff to remove the hooking cable from LTOH line.

I seized some portion hooking cable with hooking device and prepare the seizure list. Accused and Local public were asked for their signature but they refused.

We left the spot on at 12:45 PM.

It is well proved that the accused **Sri Samir Roy (user), S/O-Lt Madan Roy** is liable for prosecution as committed theft of electricity by bypassing the Energy meter of his permanent service connection under Section 135 (1)(a)&(b) of Electricity Act, 2003 and Electricity (Amendment) Act, 2007 as amended upto date.

You are hereby requested to take this complain, treat this letter as F.I.R to start a case for further investigation to arrest the accused to stop such revenue loss of WBSEDCL
