In producing herewith the arrested accused persons, namely (1) Bablu Hansda S/O- Bidesh Hansda of Lokepur Bidhan Pally, (2) Dukhen Sahish S/O- Lt. Indra Sahish of Lokepur Kadmapara, (3) Biswajit Das S/O- Purna Das of Lokepur Bakultola, (4) Mangal Dhibar S/O- Lt. Ananda Dhibar of BDR Colony, all PS & Dist.-Bankura of along with seized articles (1) One single shooter, Country made, Improvised Pipe Gun loaded with one ammunition (2) one Iron rod as per seizure list. I, ASI. Prasanta Kr. Sinha of Bankura PS, Dist- Bankura do here by lodge complaint that today 25.09.19 myself along with force C/921 Jayanta Mukherjee C/520 Debasish Roy and C/1150 Arun Kr. Shit were engaged to perform night mobile duty vide Bankura PS CC. No. 2399 dt. 25.09.19 and GDE no. 1525 dt. 25.09.19. In course of night mobile duty at heavy more area at about 21.45 hrs received a source information that (1) Bablu Hansda of Lokepur Bidhan Pally, (2) Dukhen Sahish of Lokepur Kadmapara, (3) Mangal Dhibar of BDR Colony, and others have been assembled at Kadmaghati near Kali Mandir with a view to commit any crime at that area. Then the matters informed to I/C, Bankura PS and as per his direction I called to town mobile officer SI. Pradip Kr. Sinha Mahapatra and at about 22.15 hrs reached near Kadmaghati Kali Mandir area and found some persons are present in a dark place after seen Police party they started to run. After hot chase we managed to apprehend 04 (four) person others fled away. On interrogation that persons in statement in different time. On thoroughly interrogation they confessed their named as (1) Bablu Hansda S/O- Bidesh Hansda of Lokepur Bidhan Pally, (2) Dukhen Sahish S/O- Lt. Indra Sahish of Lokepur Kadmapara, (3) Biswajit Das S/O- Purna Das of Lokepur Bakultola, (4) Mangal Dhibar S/O- Lt. Ananda Dhibar of BDR Colony, all PS & Dist.-Bankura. After disclosing our identity we searched the body of that persons after maintaining all formalities. During search one single shooter Country made Improvised Pipe Gun loaded with one ammunition recovered from the exclusive possession of accused Mangal Dhibar. On asked he failed to give any satisfactory answer for kept the Arms with him. On demand he failed to produce any documents of that Fire Arms. During searched the body of others accused persons and one Iron rod was recovered from the possession of Bablu Hansda. The recover Fire Arms and iron rod seized in proper seizure list duly signed by the accused persons and Police witnesses due to no any local people present there. After that arrested the 04 (four) accused persons after maintaining all formalities. Then the accused persons stated that one Bholanath Malakar of Natunchati Hanripara and Sk. Sabir of Lokepur also with them and also stated that they were assemble for commit crime on Bankura-Durgapur road. The arrested 04 (four) accused persons with seized articles brought to PS with a view to lodge a complaint against them.

So, I do hereby lodging complain against (1) Bablu Hansda S/O- Bidesh Hansda of Lokepur Bidhan Pally, (2) Dukhen Sahish S/O- Lt. Indra Sahish of Lokepur Kadmapara, (3) Biswajit Das S/O- Purna Das of Lokepur Bakultola, (4) Mangal Dhibar S/O- Lt. Ananda Dhibar of BDR Colony, all PS & Dist.-Bankura (5) Bholanath Malakar of Natunchati Hanripara and (6) Sk. Sabir of Lokepur both of PS & Dist.-Bankura with a prayer for start a specific case against all accused persons Under section 399/402 IPC & 25/27 Arms Act. I also producing the arrested accused persons (1) Bablu Hansda S/O- Bidesh Hansda of Lokepur Bidhan Pally, (2) Dukhen Sahish S/O- Lt. Indra Sahish of Lokepur Kadmapara, (3) Biswajit Das S/O- Purna Das of Lokepur Bakultola, (4) Mangal Dhibar S/O- Lt. Ananda Dhibar of BDR Colony, all PS & Dist.-Bankura with all seized articles before you for necessary action.
