With due respect & humble submission I Sukanta Ray, aged about-38 years, son of Subodh Roy of Vill+P.O:Metali, PS:Barjora, Dist:Bankura(W.B) begs to state that on **27.08.2019** at about **08.00am** while my cousin brother namely **Kalyan Roy** aged about 34 Yrs son of Sunil Roy of Vill+P.O:Metali, P.S:Barjora, Dist:Bankura, was proceeding towards Barjora from his residence through Durgapur-Bankura State Highway by a Motor-cycle bearing Regd.no **WB-68P/5817** to his work place **Maa Sarada Marbel House Barjora** as usual when he reached at just before Pratappur village at that time one truck being Regd.No-**WB-57/4687** which coming with high speed and negligence manner from same direction and dashed behind the said Motor-cycle .As a result he sustained severe bleeding injury .With the help of local people he immediately shifted to the **Super Specialty Hospital Barjora** for treatment thereafter shifted to **IQ City Narayana Multispeciality Hospital Durgapur** for better treatment where he succumbed due to his accidental injury on same day.

P.M was held over the dead body of the deceased at S.D Hospital Durgapur vide Durgapur P.S u/d case no -**85/2019** dated 27.08.2019.

That the accident took place due to fault ,rash and negligence driving by the part of the driver of the said Truck being Regd. No: **WB-57/4687**

After receiving information of accident we confused and received mental pain and shock and also busy for his treatment therapy thereafter busy for his cremation, social and rituals activities, which cause of delay to submit this written complaint in earlier.

So, Sir, may kindly take necessary action against the driver of truck bearing Regd. No: **WB-57/4687** as per law.
