I, Sri Susanta Kr. Bera son of Sri Bijoy Krishna Bera AE & Station Manager, Radhanagar
CCC, WBSEDCL being empowered by electricity Act 2003 Amended in 2007 do hereby lodge
complaint against accd. Sadhu Bagdi son of Lt. Ranjit bagdi of Vill: Bhattra(Bagdipara),PO:-Joykrishnapur,
PS:-Bishnupur,Dist:- Bankura for committing theft of electricity by direct hooking from nearby LT OH line
of WBSEDCL inspite of his Domestic service connection exist in his premises bearing Con ID No:-202003533.

On getting some source information of theft of electricity today on 03.09.2019 in between 11.30
hrs to 12.45 hrs I alongwith Sri Suman Chakraborty son of Sri Tarun Kr. Chakraborty, SAE(E), Jr. Engg, Sri
Anupam Chakraborty son of Sri Dilip Kr. Chakraborty, LM and other technical staff(s) of Radhanagar CCC
inspected the Domestic premises, which is located at Bhattra (Bagdipara) of the aforesaid accd person
and LT OH line of WBSEDCL.

During inspection it was detected that the aforesaid accd. Person was committing theft of
electricity by direct hooking by means of 2Nos single core PVC cable fitted with 2Nos hooking devices
was found hooked with the LT OH line of WBSEDCL and other end of of the hooking cable to connect
to the outgoing of the Mainswitch, which was Off in position. Thus he has avoided proper registration
of unit in the energy meter bearing No:-OB4088708 for his Domestic consumption. As a result of which
WBSEDCL incurred huge loss of revenue.

I prepared inspection report on the spot and assessed the consumption of load which was
detected by Tong Tester as 0.300Kw.

I directed Sri Anupam Chakraborty, LM to disconnect the Domestic service connection having
Consumer ID No:- 202003533 and Meter No:-OB4088708 from LT OH line of WBSEDCL and to remove the
hooking cable, accordingly he did the same which I seized and preparing seizure list on the spot and left
the site at about 12.46hrs.

Copy of Inspection Report & Seizure List could not be handed over to the accd. Person
or his representative due to their absence in the spot.

It is well evident that said accd. Sadhu Bagdi of Vill : Bhattra (Bagdipara) Po:- Joykrishnapur,
PS:- Bishnupur, Dist: Bankura committed theft of electricity by direct hooking from nearby LT OH line of
WBSEDCL inspite of his service connection exists. As such he is liable for prosecution U/S 135(1)(a) & (b) of
the Electricity Act 2003 Amended in 2007.

Kindly treat this complaint as FIR and take necessary step against the accd person.

During inspection it was detected the aforesaid aced. person was committing theft of electricity by direct hooking by means of 2 nos. single core pvc cable fitted with 2 nos hooking devices was found hooked with nearby LT line of WBSEDCL and other end of the hooking cable to connect the outgoing of the main switch, which was off in position. Thus he had avoided proper registration of unit in the energy meters bearing no. OB4088708 for his domestic consumption. As a result of which WBSEDCL incurred huge loss of revenue and assess the consumption of load which was detected as 0.300kW.


