Sub. Prayer for lodging FIR against arrested accused Bhairab Dutta (27 yrs.) s/o Sri Madan Dutta of Vill. - Palsora, PO- Jhantipahari, PS Chhatna, Dist. Bankura.

In producing herewith accused person namely accused Bhairab Dutta (27 yrs.) s/o Sri Madan Dutta of Vill. - Palsora, PO- Jhantipahari, PS Chhatna, Dist. Bankura, along with seizure list and seized items as described below. I beg to state that on 25/09/19 at about 05.45 hrs, I received source information that the above aced has kept I.D Liquor and country liquor under his possession in Trinayani Hindu Hotel owned by him, at Ankit more, Jorehira, PS- Chhatna illegally with an object to sale. I diarized the information under Jhantipahari P.S. GDE No-515 at 05.45 hrs dated- 25/09/19 and as per order of O.C Chhatna P.S. I along with force left for spot to work out the information with the govt. supplied kits box containing white cloth, sealing wax, seal, papers, carbons, candles etc. I had been to the said Hotel at about 06.15 hours. Seeing police one persons tried to flee away.

However I could detain him and asked about his identity. He revealed his name and identity as above as well as informed also that it was his Hotel run as well as managed by himself. However I along with the said accused started a search inside the Hotel and found the following Country Spirit and I.D Liquor in the following place.

I interrogated him about the purpose of the stocking and possessing of the liquid said to be Country Spirit and I.D Liquor. He replied it was his business. However he could not show any documents/papers in support of the possession of the said articles.

As such, I seized the following items as ALAMAT under proper **Seizure List between 06.15 and 07.15 hrs** & took up one bottle of each brand as samples, leveled and sealed accordingly.

- 1) 10 Nos. of "DIL Se" bottles of 375 ml. @ Rs. 22/- per bottle out of which one bottle seized as sample packed, labeled and sealed with sealing wax
- 2) 06 Nos. of "Captain" bottles of 600 ml. @ Rs. 75/- per bottle out of which one bottle seized as sample sample packed, labeled and sealed with sealing wax.
- 3) 02 Pcs. of Jarrican containing approx. 35 ltrs. Of ID liquor @ Rs. 125 per litre from which Approx. 375 ml. of ID Liquor is taken as sample sample packed, labeled and sealed with sealing wax

Since the allegation against him of possessing, the I.D liquor/C.S illegally without any valid papers for the purpose of selling in the shop has prima-facie been made out and for the interest of proper investigation. I **arrested the above accused at 07:25 hrs** accordingly.


Therefore, I pray before you to start a case under proper section of law against the said arrested accused.
