Sub: Complaint against Pintu Layek(User), S/O Chakradhar Layek of Location- Sibarampur, PS: Indpur, Dist.: Bankura, for committing theft of Electricity by Direct Hooking from nearest L.T.O.H. line at his own cable TV network.

Sir,

I, MD Afroz Ahmad (35), Assistant Engineer & Station manager of Indpur CCC, PO+PS: Indpur, Dist: Bankura do hereby lodge a complaint against Pintu Layek(User), S/O Chakradhar Layek of Location- Sibarampur, PS: Indpur, Dist.: Bankura, for committing theft of Electricity by Direct Hooking from nearest L.T.O.H. line at his said above cable TV network.

On today i.e. 19.09.2019 at about 10.00 hrs myself along with 1) Sumit Kumar Misra, Sr. SAE(E) and 2. Saroj Kumar Biswas (Hg.Sr.LM Indpur CCC and others left for location Sibarampur for holding raid following a source information.

We reached location Sibarampur at 11.00 hrs and came to the site of cable owner cum occupier of Pintu Layek(user), observed & found that he was using electricity unauthorized by direct hooking from nearest LTOH line by installing one power supply unit(FFC CATV EQUIPMENT-220 V, 3 Amp.) for the commercial purpose in the cable TV network in the area of Sibarampur. Generally, this type of power supply unit is used to serve the power for (house to house) cable network channel. So, his illegal hooking line was disconnected. The permanent address of accused Pintu Layek is in the Village-Keliapathar as learnt by the concern villagers.

I prepared the inspection report and seized the articles in presence of witness 1) Sumit Kumar Misra, Sr. SAE(E), Indpur CCC 2) Saroj Kumar Biswas (Hg.Sr.LM -Indpur CCC), Indpur CCC under proper seizure list. Since the cable owner Pintu Layek is not available at the time of our inspection and other inmates are reluctant to co operate us. one power supply unit(FFC CATV EQUIPMENT-220 V, 3 Amp.) along with hooking arrangement including connecting device by pvc wire of length approx- 8(eight) Mtr was seized. Our team left the site at about 11.20 hrs. So Pintu Layek, has committed theft of Electricity in his cable network by direct hooking from nearest LTOH line and liable for prosecution u/s 135(1) (a) of Electricity Act 2003, and with amendment Electricity Act 2007.

Kindly treat this Complaint as FIR and take necessary action.
