Sir,


With due respect I beg to report that today i.e., on 28.08.19 at about 16:00 hrs Joypur Block BJP organized a political meeting at Hetia High School ground near Hetia Market under Joypur PS jurisdiction. As such myself alongwith force of Joypur PS and officers and force of other units had been to Hetia Market to maintain law and order vide Joypur PS Spl. CC no.27/19 dtd.28.08.19. Sri Soumitra Khan, MP, Bishnupur PC was likely to attend the meeting. But at about 16:30 hrs Smt. Sujata Khan w/o Soumitra Khan of Durlavpur, PS Gangajalghati, Dist. Bankura with BJP supporters reached at meeting ground. In the meantime while the BJP supporters were proceeding towards Hetia from Kumbhasthal side through Routkhanda, at that time at Routkhanda Masjidtala a hot altercation followed by assault took place between them and the locals of that area. Smt. Sujata Khan while giving speech on dais threw some remarks towards a religious community. As such the supporters who had gathered there to attend the meeting get furious and started to blame the Police party for the incident at Masjidtala. Myself, SI Alokesh Pati of Kotulpur PS, ASI(AB) Shyamal Hore of Bishnupur EF Line and force tried to pacify them but they did not pay heed to our words and (1) Chitta Ghosh of vill.- Muidhara, PS Kotulpur, Dist. Moynapur Domdihgi all of PS Joypur, Dist. Bankura and 100/150 others started to abuse us by slang languages. Thereafter they started to push us back and obstructed us to perform our official duty. Before we could understand their motive they started pelting stones and brick bats aiming Police party. As a result SI Alokesh Pati of Kotulpur PS and Const Nepal Chandra Saha of Joypur PS, JC Sumanta Mahato, JC Ajit Kr. Hembram, JC Nandalal Rajak, JC Jayanta Duley all of Bankura Police Hqrs & CV Abhishek Mondal of Joypur PS who were performing duty sustained serious injury on their persons. Not only that the said mob tortured the Police vehicle of Joypur PS bearing no. WB 68C/6278 and damaged it badly. Subsequently, myself informed the matter to you and other superior officers and requested for re-enforcement of more force. Hearing this the said mob fled away.

Under the circumstances, I would like to request you to start a specific case against the aforesaid persons and 100/150 others, so that the alleged persons get punishment for their such act.
