Dear Sir,

I, Sri Biswanath Barui, S/O- Sri Swadesh Barui, AE & S.M, Raipur CCC, WBSedCL, being authorized under the Electricity Act 2003 and Electricity Act (Amendment) -2007, do hereby lodge complaint against accused **Sankar Mandal, S/O-Lt. Bankim Mandal residing at Vill-Siromonipur, P.O.- Siromonipur, P.S.-Raipur, Dist- Bankura, Pin-722134** who was committing theft of electricity by direct hooking from nearby LTOH line of WBSedCL for the electricity energy consumption of his domestic purpose.

Following a secret source information on 23.09.2019 between 11.35 hrs to 11.45 hrs, I along with 1) Sri Khokon Murmu, S/O- Shri Debsaran Murmu, SR. S.A.E, and Sri Manoranjan Hazari, S/O- Bangshi Hazari L.M., all of Raipur CCC, WBSedCL inspected the domestic premises at Village + P.O.- Siromonipur of accused **Sankar Mandal, S/O- Lt. Bankim Mandal residing at Vill-Siromonipur, P.O.- Siromonipur, P.S.-Raipur, Dist- Bankura, Pin-722134**. During inspection it was detected that said accused person was committing theft of electricity by direct hooking from nearby LTOH line of WBSedCL.

The consumption load which was detected as 1 KW by the Inspection team and accordingly the inspection report was prepared. I directed Sri Manoranjan Hazari, L.M, Raipur CCC to de-hook the hooking cable from LTOH line of WBSedCL and he did the same which I seized 01 no 2 core PVC cable approx length 10 feet as a sample basis after preparing seizure list.

It is well evident that the accused person was committing theft of electricity by direct hooking from nearby LTOH line of WBSedCL as such he is liable for prosecution u/s 135(1)(a) of Electricity Act 2003, Amendment in 2007. Kindly treat this complaint as F.I.R.
