Sir,

In producing herewith arrested accd person namely Ajit Bauri ( 57 yrs) s/o Lt Motilal Bauri of Lalbandh College para Ward No-03 under Bishnupur Municipality PS-Bishnupur, Dist Bankura along with seized 12(twelve) bottles of Country Spirit(Brand "CAPTAIN" brand 650ml each) under proper seizure list I SI Biswajit Banerjee do hereby lodged a written complaint against Ajit Bauri ( yrs) s/o Lt Motilal bauri of Lalbandh College para Ward No-03 under Bishnupur Municipality PS-Bishnupur, Dist Bankura to the effect that on 22.10.19 at 19.05 hrs acting on a source information regarding selling of liquor illegally held raid with force C/1418 Laxmikanta Bauri , C/1135 fatik Mandal ,C/31 Bishnupada Saha vide Bishnupur PS CC No- 4765/19 dt 22.10.19 in the house of said Ajit Bauri and found he was engaged in selling ID liquor and other liquors to the customers in lieu of money. On seeing police, customers fled away from the house and on search I found about 12(twelve) bottles of Country Spirit (Captain) 650 ml each from his possession. Being asked Ajit Bauri failed to produce any valid documents in support of selling liquor and could not give satisfactory answer in his regard. I seized the liquor bottles(country spirit) under proper seizure list as he violatal the Bengal Excise Rule.

Therefore I pray that necessary legal action may kindly be taken against Ajit Bauri for seeking liquor illegally.
