Sir,

In producing herewith the following accd. persons namely a) Akhtar Sk@ Jamai, s/o: Abdur Rajjak- at present residing at vill. Shyamsundarpur, P.S. Bishnupur, Dist. Bankura [Permanent address: Ghatihir, P.S. Kapalpura, Dist. Majaffarpur, Bihar] b) Mahammed Hazra, s/o: Golam Hazra of Kulajjuri, P.S. Bishnupur, Dist. Bankura c) Kartick Majhi, s/o: Basudev Majhi of Balshi, P.S. Patrasayer, Dist. Bankura along with seized articles viz fire arms, ammunitions, long knife, bhojali, iron rod and other articles(details in seizure list), I, S.I. Shyama Prasad Pradhan of Bishnupur P.S, would like to lodge a suo- motto complaint against aforesaid accd. persons and their associates to the effect that today, as per schedule, I left the P.S. with force for performing anti crime patrolling duty in Bishnupur town and its areas, adjacent to NH560. This refers Bishnupur P.S. GDE No. 945, dt. 22.10.19 and CC No. 4767/19, Dt. 22.10.19.

In course of performing said duty, at 22:15hrs, got a piece of information that few persons were seen at Dhangasole jungle along Bishnupur- Sabrakone pitch road with nefarious motive. Accordingly, I informed the matter to IC Bishnupur P.S and as per his instruction, I left for executing that piece of information. Besides, I telephoned SI Biswajit Banerjee- the town mobile officer for my assistance. We met at Light House more at 22:35hrs and left for Dhengasole jungle.

My source gave me the exact location. We kept our vehicles at a certain distance and left for the place on foot along two flanks and reached at the spot at 23:05. After reaching at the place, we switched on the light and that instant 5/6 persons ran away breaking our cordon. we managed to catch hold of 03 persons.

I asked them to inform their name and particulars and the reason after their assembly in jungle. They, at initial stage, tried to befool us. After a brief interrogation on spot, they provided me with their names and particulars as noted above. After that I with the help of my accompanying Officer and forces searched their persons and found one

loaded country made fire arms from the exclusive possession of Akhtar Sk@ Jamai, as long knife from the exclusive possession of Mahammed Hazra, an iron rod from the possession of Kartick Majhi. I asked them their reason after possessing those incriminating weapons and to produce valid documents in support of possessing those weapons. They could produce nothing. I interrogated them thoroughly and after thorough interrogation, they stated that they themselves along with Abbas Sk of Beliara, P.S. Bishnupur, Dist. Bankura; Sk. Israfil of Shyamsundarpur, P.S. Bishnupur, Dist. Bankura; Selimuddin Khan of Nabkola, P.S. Garhbeta, Dist. Paschim Medinipur and Riyajul Khan@ Budhan of Shyamsundarpur, PS. Bishnupur, Dist. Bankura, Rana Chatterjee of Pragati Pally, Jhapor More, Bishnupur, Bankura and 02 others who are unknown to them got assembled there for committing dacoity either in Jalan's petrol pump or in nearby cold storage. Abbas Sk of Beliara, P.S. Bishnupur, Dist. Bankura was the gang leader and he formed the team for committing crime. I searched the PO and found 01 bhojali within a nylon bag and liquor bottles. I seized all those under proper seizure list [details in seizure list] in between 23:15hrs and 23:35hrs. Thereafter, I arrested them maintaining legal formalities and brought them to P.S.

Under the above, I pray to you to start a cog. case against aforesaid accd. persons under appropriate section of law.
