

Sub: Complain against Mrityunjay Dubey, S/o Late Laxmi Narayan Dubey, Vill Panchamba, PO Banasuria, PS Gangajalghati, Dist Bankura for theft of Electricity from Direct OH line of WBSEDCL.

Sir,

I Biswanath Dey, S/O- Harekrishna Dey, aged about 32 years, A.E. & Station Manager of the GangajalGhati Customer Care Centre being authorized under the Electricity Act. 2003 and Electricity (Amendment) Act-2007, do here by lodge complaint against Mrityunjay Dubey, S/o Late Laxmi Narayan Dubey, Vill Panchamba, PO Banasuria, PS Gangajalghati, Dist Bankura for theft of electricity for his commercial needs by direct hooking with the help of hooking device and PVC wire from near-by LT lines of WBSEDCL, U/S.- 135(i)(a) of Electricity Act 2003 and Electricity (Amendment) Act-2007, as Stated here under.

That on 23.10.2019 in between 14:25 Hrs. and 14:50 Hrs. myself along with (I)Sitaram Banerjee, SO, S&LP, Bankura Regional office, ii) Ratan Gour, SAE(E) Gangajalghati CCC iii) Sadhan Ch Pramanik (37), S/o Late Shantiram Pramanik, Sr TSH, Gangajalghati CCC iv) Deepjyoti Pan, OE, Gangajalghati CCC and others on the basis of source information inspected the commercial premises of Mrityunjay Dubey, S/o Late Laxmi Narayan Dubey , Vill Panchamba, PO Banasuria, PS Gangajalghati Dist Bankura and found that said Mrityunjay Dubey was using electricity unauthorizedly and dishonestly in his commercial premises by direct hooking with the help of hooking device and PVC wire from nearby OH LT lines of WBSEDCL - causing huge loss of revenue of WBSEDCL . So, Mrityunjay Dubey committed theft of electricity and liable for prosecution U/S.-135(i)(a) of Electricity Act-2003 and Electricity (Amendment) Act-2007.

I prepared the inspection report and assessed the load which comes to 0.746 KW. The unauthorized hooking arrangements and PVC cable was disconnected as per rule of WBSEDCL with the help of technical staff. I seized hooking arrangements and part of PVC cable and prepared seizure list. The inspection team left the site at 14:50 hours of date.

So you are hereby requested to treat this complaint as F.I.R and arrange for its investigation.
