Sub: Prayer to lodge FIR against shopkeeper Dharmaraj @ Dhama Gorai S/O-Lt. Badal Ch. Gorai of Vill-Onda Mishrapara, P.S-Onda, Dist-Bankura.

Sir,

With due respect and humble submission, I ASI Shyamananda Mukherjee of Onda PS do here by lodge a written compliant to the effect that on 27.10.19 at 15:45 hrs. I ASI Syamananda Mukherjee of Onda PS along with force namely C/03 Asim Chakraborty, C/1642 Anjan Patra left Onda PS for Onda Bazar by Govt. Vehicle bearing no-WB 26C/7361 to work out an information and hold raid regarding prohibited illegal fireworks (sound crackers) as per order of O/C Onda P.S. As per your instruction laid down in Onda P.S GDE No. 1074 dated 27.10.2019 vide Onda PS CC No. 2701/19 dated 27.10.2019.

Myself along with force reached Onda Bazar under Onda P.S and noticed that one person is selling banned prohibited fireworks at one Stationary Shop. Accordingly, I ASI Syamannanda Mukherjee instructed the force to cordon the area and then held raid at the shop. During raid I found some quantity of prohibited and illegal fireworks which was stored in a concealed place of the shop. I would like note here that when I tried to apprehend the shopkeeper, he managed to flee away from this place. I could not able to apprehend the said shop keeper. I searched the shop very carefully in presence of local inhabitant persons and could not found any valid license regarding storing and selling of those fireworks. Accordingly, finding no alternative, I seized the following fireworks which were found hidden in a big size bag:

- (1) Sixty-two (62) Packets of prohibited firecrackers marked as "KING KOBRA CHOCOLATE BOMB" ten (10) pieces in each labeled as B.K Industries marked as exhibit "A".
- (2) One plastic packet containing 50 pieces "CHOCOLATE BOMB" blue colour (any type of label of marked is not found) marked as exhibit "B".

I have seized the articles as per proper seizure list which is duly signed by the local witnesses

I caused a local enquiry and it is learnt that the name of the shop keeper is Dharmaraj Garai @ Dhama Gorai S/O-Lt. Badal Ch. Gorai of Vill-Onda Mishrapara, P.S-Onda, Dist-Bankura. It is also learnt that he used to sell these prohibited sound crackers from his shop since last few years during different occasion. Locally it is also learnt that he is no other than the said person who fled away seeing the Police.

I, would therefore, request you to kindly lodge a FIR for causing proper investigation of the matter and also take proper legal action against shopkeeper Dharmaraj @ Dhama Gorai S/O-Lt. Badal Ch. Gorai of Vill-Onda Mishrapara, P.S-Onda, Dist-Bankura.

This is for favour of your kind consideration. I have typed this complaint at Govt supplied computer at Onda Police Station.
