Sub: - Prayer for lodging F.I.R.

Respected Sir,

In producing herewith one tractor bearing registration No WB-88D/1066 with trolley (without registration number) loaded with sand under proper seizure list duly signed by the witnesses along with Arrested driver of above Tractor namely Tapas Ruidas (27), S/O- Sunil Ruidas of Jamkuri, P.S- Patrasayer, Dist- Bankura.

I SI Shyamalendu Chowdhury beg to inform you that today (19.10.19) myself along with C/50 Manik Thakur, C/991 Binod Mandi & NVF- Tapan Adhikari left P.S for morning mobile duty vide CC No.- 2199/19 Dated:- 19.10.19 and at about 12:05 hrs as per telephonic information from O/C Patrasayer P.S that one sand loaded Tractor is coming from Telisayer to Jamkuri side after received this information myself along with force left for Jamkuri to work out information. At about 12:35 hrs myself along with force arrived at Jamkuri and found the above noted sand loaded Tractor is coming. On seeing police party the driver of Tractor try to fled away after leaving the tractor. After a hot chased we could apprehend the above noted driver. Being asked the driver failed to produce any documents or valid challan about the sand or the valid papers of Tractor No.- WB.- 88D/1066 on asked he stated that he loaded the sand from Darakeswar river as per order of register owner of Tractor No.- WB.- 88D/1066. On enquiry local people at the area stated since long some tractor comes Darakeswar river ghat for extracting sand illegally from the river bed. The fact I inform to O/C Patrasayer P.S and arrested the above noted accused driver after observing all formalities and guidelines of Apex Court regarding arrest, issued Memo of arrest, Inspection Memo and conveyed him the ground of his arrest and seized the sand loaded tractor No.- WB-88D/1066 with trolley as per seizure list duly signed by witnesses as well as Police force and accused driver also.

Under the above fact and circumstances, in suspicion of stolen property, I pray before you that a specific case started against the accuse driver Tapas Ruidas (27), S/O- Sunil Ruidas of Jamkuri, P.S- Patrasayer, Dist- Bankura under proper section of law and arrange for its investigation.
