Sub: Prayer for lodging FIR against Sukumar Gorai @ Baiddyanath (32 yrs), S/o- Gopal Gorai of Vill- Sonadipa, Purba Nabason GP, PS- Sonamukhi, Dist- Bankura.

Sir,

In producing herewith the seized article (1) Two plastic Jariken (marked as SL no- 1& 2) containing approx 10 Ltrs each and total approx 20 Ltrs of ID liquor, (2) two pipe fitted funnel, (3) Two bottle of ID Liquor of approx 375 ml collected as sample from the each Jariken SI No 1 & 2 and duly sealed and labeled by me, I SI Kuchil Kr. Chakraborty of Sonamukhi PS do here by lodge complaint against one Sukumar Gorai @ Baiddyanath (32 yrs), S/O- Gopal Gorai of Vill- Sonadipa, Purba Nabason GP, PS- Sonamukhi, Dist- Bankura to the effect that on 22.10.19 at about 18:50 hrs received secret information over telephone from duty officer of PS that illegal manufacturing and sale of ID liquor is going on at the house of Sukumar Gorai @ Baiddyanath (32 yrs), S/O- Gopal Gorai of Vill- Sonadipa, Purba Nabason GP, PS- Sonamukhi, Dist- Bankura. (This ref. to Sonamukhi P.S. G.D.E. no- 985, Dt.- 22.10.19) Accordingly as per order of O/C, Sonamukhi P.S. I accompanied by force namely C/492 Phani Bhushan Sarkar, C/881 Prabir Pakhira & NVF 690 Prakash Satpati left for Vill- Sonadipa, Purba Nabason GP, PS- Sonamukhi, Dist- Bankura to work out the information.

On 22.10.19 at about 19:25 hrs I accompanied by force reached near the house of Sukumar Gorai @ Baiddyanath (32 yrs), S/O- Gopal Gorai of Vill- Sonadipa, Purba Nabason GP, PS- Sonamukhi, Dist- Bankura. While proceeding to his house as identified by the local people, Seeing Police some persons who were sitting in the court yard of his house and taking liquor started to flee away. We chased behind them. But all of them including manufacturer Sukumar Gorai managed to escape from there. I called some disinterested persons. In presence of some villagers and police personnel in between 19:35 hrs to 19:55 hrs searched the house from where those persons fled away and found (1) Two plastic Jariken (marked as SL no- 1& 2) containing approx 10 Ltrs each and total approx 20 Ltrs of ID liquor, (2) Two pipe fitted funnel, (3) Two bottle of ID Liquor of approx 375 ml collected as sample from the each Jariken SI No 1 & 2. On local enquiry I came to learn that the owner of that house is Sukumar Gorai @ Baiddyanath (32 yrs), S/O- Gopal Gorai of Vill- Sonadipa, Purba Nabason GP, PS- Sonamukhi, Dist- Bankura who was managed to escape from there. He has been manufacturing and selling liquor illegally from his house and he is running this illegal business since long. I arrange to collect one bottle of ID liquor as sample from each Jariken containing liquor and sealed, labeled, and seized the same in presence of police witnesses namely C/492 Phani Bhushan Sarkar, C/881 Prabir Pakhira both of Sonamukhi PS under proper seizure list duly signed by them. On several request no villagers came forward to sign in the seizure list. The seizure of the above articles was made in between 20:05 hrs to 20:25 hrs duly Signed by the Police person.

On the spot on being search and ask no one in favour of him came forward and produce any valid license against his illegal manufacture and sale of ID liquor. The approximate value of the article seized and destroyed is Rs 2250/- only.

Under the above circumstance, I request you to start a specific case against the said Sukumar Gorai @ Baiddyanath (32 yrs), S/O- Gopal Gorai of Vill- Sonadipa, Purba Nabason GP, PS- Sonamukhi, Dist- Bankura and arrange for its investigation.
