Sub: Lodging of FIR U/S 135(i)(b) of the electricity act of 2003 amended in 2007 against accused Tapan Kumar Singh, S/o-Mantu Bhusan Singh, Vill- Agra , P.S & Dist- Bankura.

Dear Sir,

I Bikash Kumar Dalal S/o LT Pravakar Dalal, A.E & S.M Lalbazar CCC, W.B.S.E.D.C.L being empowered by electricity act of 2003 amended in 2007 do hereby lodge complaint against accused Tapan Kumar Singh, S/o-Mantu Bhusan Singh, Vill- Agra , P.S & Dist- Bankura to the effect that receiving an information the aforesaid accused person is committing theft of electricity by bypassing the meter no: B3119855 with cutting of service cable for his own Poultry Farm .

On getting information, between 13.20 hrs to 13.40 hrs Dated-15.11.2019. I alongwith, Nirmal Kumar Majhi(A.C.M), Joygopal Debnath(T.S.H) and Mohammad Jahangir(O.E) of Lalbazar CCC, inspected the poultry farm of Tapan Kumar Singh, S/o-Mantu Bhusan Singh, Vill- Agra , P.S & Dist- Bankura.

During inspection it was detected that the accused Tapan Kumar Singh, S/o-Mantu Bhusan Singh, Vill- Agra , P.S & Dist- Bankura has committed theft of electricity by bypassing the meter no: B3119855 with cutting of service cable having id_no: 201476443 in his poultry farm, Agra under Lalbazar CCC .

I prepare the inspection report at site and assessed load of 852W. I directed Sri Nirmal Kumar Majhi(A.C.M) to cut the tapping portion of the service cable and disconnect his service from LTOH line.

From the above arrangement he was using the following electrical equipments.

1) 1 no. pump @ 373 W, 2) 1 no. bulb @ 200 W 3) 3 nos fan @ 60 W. 4) 11 nos. LED @ 9W.

Out of which I seized the following:

- 1) Tapping portion of service cable 2 meter approx with 3pin switch board.
- 2) 1 no. bulb(200 W).

Seizure list was prepared at the site, representative of the accused person refused to sign.

The inspection team left the premises at Vill- Agra on 13.40 hrs.

The accused person has committed an offence U/S 135(i)(b) of the Electricity Act 2003 & subsequently Electricity (Amendment) Act-2007.

You are requested to take cognizance of this complaint and treat it as FIR and action may be taken as per rule.
