I, Sri Ashish Kr Ghosal, S/o Lt Shyamapada Ghosal, Vill + PO – Junbedia, Dist-Bankura aged about 56 and working as Dy Postmaster, Bankura Head Post Office do hereby submit the following complaint in the official capacity -

- For the purpose of ATM operations with Post Office (Bankura HO), CMS Info Systems Limited authorized Signatories any one from Group I and any one from Group II mentioned in their resolution dtd 30th Dec 2015, among which Sri Amit Kumar Nandi (Employee Code 4105189) was authorized as Service Associate – ATM under Grup I, under signature of Ms Akshata Rane / Mr. Gajanan Ghadigaonkar (E. Code 1105255) – Designation: Trainee HR/Associate HR on behalf of Board of Directors of CMS Info Systems Limited.
- 2. Taking advantage of their daily performance in Cash Loading in the ATM of Bankura Head Post Office, Sri Amit Kumar Nandi (Employee Code 4105189) Service Associate ATM (Gr-I) attended at Bankura Head Post Office on 08-11-2019 at about 10:00 Hrs, received the cash of 10 lakh from Sri Shital Rudra, Treasurer of Bankura Head Post Office Treasury and Sri Amit Kr Nandi told the treasurer that Loading Completed in the ATM as usual manner by opening the ATM Machine vault by using his secret own credential. He also told to the Treasurer that he failed to generate the Cash Loading Report incorporating the loaded amount due to system out of order and he assured to the Treasurer at that time that he would generate the same after a while when the system will be in functional. But actually the cash was not loaded into the ATM Machine and till now he did not give the cash replenish report of above 10 lakh to Bankura HO and he had taken away the whole amount.
- 3. Said Sri Nandi as his official capacity was the sole custodian of the ATM Vault Locking system.
- 4. But Sri Nandi never attended this office since the last loading on 8-11-2019 either to return the money or to deliver any report.
- 5. Subsequently when CMS personal Sri Tanmoy Biswas (Employee code 4103047) and Sri Gobinda Mondal (Employee code 4104588) attended this office on 16-11-2019 for cash loading into the ATM of a sum of Rs 15 lakh they confirmed that the amount of 10 lakh dtd 8-11-2019 was not loaded by Sri Amit Kr Nandi in the ATM Vault at all and it is crystal clear that said Sri Nandi having the key of ATM machine and his secret ATM Vault opening Credential misappropriated the Govt money of Rs 10 lakh on 08-11-2019.



It is established prima facie that that Sri Amit Kumar Nandi (Employee Code 4105189) the employee of CMS Info Systems Limited willfully done such fraudulent activity for his personal gain and cheated the Govt by misusing his official power which is offensive and against the public interest. The activity from the part of said Nandi and his Employer may kindly be treated as "Cognizable Offence" and considering all above, this Department urges for depth Inquiry into this case. Kindly lodge FIR against them under relevant section of IPC and it is also requested to kindly arrange for recovery of Rs 10 lakh from the fraudulent person and credit to Department of Posts, India as early as possible.
