Sir,

With due respect I, the undersigned do here by lodging a written complaint to the effect that today (26.11.19) at 02.53 PM I accompanied with my colleagues Sanjay Kr Singh (Executive Engineer) and Riazuddin Mandal (Junior Engineer) found during our visit at Kantabandh under Barjora PS that some unknown miscreants were committing theft by cutting and loading 'Babla' trees logs over one truck bearing Reg.no-WB 37A 9707 from embankment of Kanjore Reservoir at Kantabandh. On seeing us they all managed to flee away and we managed to apprehend the driver of the said truck namely Mangal Bauri s/o Lt Shristidhar Bauri of Hamirhati, PS Sonamukhi, Dist Bankura. On demand driver of vehicle failed to produce any valid papers and documents of said loaded tree logs. We brought the Truck loaded logs and driver to Barjora PS. Owner and driver of said Truck, and others collecting the said tree logs from Kanjore Reservoir at Kantabandh area and transporting the same for their wrongful gain and wrongful loss to Govt. Property.

Therefore, I pray to you that a specific case may kindly be started against (1) Driver of vehicle WB 37A 9707 namely Mangal Bauri s/o Lt Shristidhar Bauri of Hamirhati, PS Sonamukhi, Dist Bankura (2) Owner of Truck bearing registration no. WB 37A 9707 and others under proper section of law.
