To The Officer in Charge, Chhatna PS, Bankura.

Sir,

In producing herewith the arrested accused person namely Dayamay Mandi(54y) S/O-Lt Kumar Mandi of Jamthole, P.O-Besora, PS-Chhatna, Dist-Bankura along with seized articles respectively (1) 03 pcs Jaricans contained approx 25 litters ID-Liquor, one bottle of ID- Liquor approx. 375 ml. collected as sample (Rs. 125/ per litter) (2) 02 pcs aluminum handi, (3) 01 unit of D/A, (4) 03 nos of "DIL KHUSH" bottles (375 ml.), per pc Rs- 22/-, I beg to report that in course of my mobile duty today on 18.11.19 at about 05.15hrs, I received secret telephonic information that one person is preparing ID-Liquor and selling in his house namely Dayamay Mandi(54y) S/O-Lt Kumar Mandi of Jamthole, P.O-Besora, PS-Chhatna, Dist-Bankura, I informed the matter to O/C Chhatna PS, as per his direction myself along with C/310 Himungsu Gorai, C/1016 Kanchan Kr Gupta, HG-Ranjit Debsharma rushed to the spot. On reaching at about 06.05 hours there we found that one person engaged in preparing ID- Liquor, on search found the above noted articles are stock at said house. Getting the scent of police he tried flee away but after a hot chase police party managed to apprehend above noted accused person. On being asked he could not produce any valid documents or receipt/Challan from any competent Govt. authority in support of preparing ID- Liquor and stock liquors. I seized above noted liquors from the possession of the above noted accused person under proper seizure list and duly signed by the police personnel as none was available to sign the seizure list and arrested the accused person. One copy of seizure list supplied to the accused person after observing all legal formalities.

It is evident that the above noted accused person is liable to be prosecuted U/S 46 (A) BE Act.

So, I pray before you that a case may kindly be started against the above noted accused person under proper section of law and oblige
