Sub: Complain against **Ibrahim Mallick (user)**, Village- Jadavnagar near primary school Bankura, PS-Joypur, Dist-Bankura for theft of electricity by taping from the incoming service cable & bypassing Single phase electric meter for his Domestic connection.

Dear Sir,

I Arif Mondal, s/o Late Jiad Ali Mondal Assistant Engineer & Station Manager Joypur CCC, do hereby lodge a complaint against **Ibrahim Mallick (user)**, village- Jadavnagar near primary school Bankura, PS-Joypur, Dist-Bankura for theft of electricity by taping from the incoming service cable & bypassing Single phase electric meter for his Domestic connection device arrangement. In reference with a secret source information undersigned reached at the spot as above place at around 16.20Hrs on dt.25.11.2019 together with 1. Swarup Kumar Das (SAE) & 2.Haradhan Ghosh (ACM) of Joypur CCC and found the theft.

During inspection it was detected that the said accused person was enjoying electricity by taping from the incoming service cable in a meter of whose display was ok. Thus the consumer was obstructing the actual registration of the power which he was using for his Domestic connection.

Then an inspection report was prepared at the spot where the load assessed as 200watts. I intimated Haradhan Ghosh (ACM) to disconnect the line and seized the hooking material. Thereafter, he de-hook the hooking material from the LT service line. Accordingly, I prepared the seizer list at the spot. Copy of seizure list & inspection report could not be handed over to the accused person because of his absence in the spot. The inspection team left the site at 17.00Hrs.

It is well established that aforesaid accused person **Ibrahim Mallick (user)**, was committing theft of electricity by taping from the incoming service cable & bypassing the meter device arrangement and so the person is liable for prosecution under section 135(1)(a) of Electricity Act 2003 amendment in 2007.

As such you are requested to treat this letter as FIR.

This is for your kind information and necessary action please in this regard.
