As you are aware that on 12-09-2019 the state administration had given us the possession which of Feed plant ,Hatchery ,Guest House, Office building ,staff quarter, Breeding farm and other area of Amrit hatcheries Pvt Ltd located at Mouza Ambari Hazarigram and Bethjuria, P.S. Onda District Bankura, West Bengal Pin 722144 under the Secritisation and reconstruction of Financial Assets and Enforcement of Securities Interest Act 2002(also known as the SAFAESI Act) from Punjab National Bank.

We would like to inform you that the Punjab National Bank applied before the District Magistrate for the permission, the District Magistrate and the Block Development Officer on 25.07.2019 took the possession of the property and handed over such possession to the authorized officer and Chief Manager to the Punjab National Bank.

Based on the whole process of buying under SARFAESI act, the Punjab National Bank issued the sale certificate on 03.09.2019 and given us the physical possession on 12.09.2019 of the site.

We want to bring to your notice that on 15/11/2019 night at around 12.30 A.M several people under the leadership of Mr. Chandan Chakraborty of Village Liyada gathered at the gate and tried to entire forcefully inside the gate. We immediately inform the police. We would like to inform you that when the police person reached at the spot for enquiry and talked with our security guard at that time some number of people forcefully entered into our area. Till today they are inside our area.

In view of the above you are requested to intervene into the matter and take appropriate recourse to vacate our area from the miscreants.
