Dear Sir,

Subject- Forceful, illegal and unlawful attempt made by employees/guards/officers of Skylark Feeds having its office at Dharamgarh Bohli Road, Safidon, District-Jind, Haryana-126112 to dispossess/deprive/remove Rowland Tracom Pvt. Ltd from its lawful possession of land measuring 354 decimals situated at Dag No.1, JL No.280, Mouza Ambari, Hazarigram, District-Bankura.

I, am Bharat Pal son of Netai Chandra pal resident of vill-Liada, po-Gorasole ps-Onda, dist-Bankura pin-722144. I am an employee working for Rowland Tracom Pvt. Ltd (hereinafter referred to as "Rowland Tracom"), which has its registered office at 3A, Chandra Kunj, 3, Pretoria Street, Kolkata- 700071.

I state that Rowland Tracom has been in possession of land measuring approximately 354 decimals at Mouza Betjhuria, J. L. No. 280, Khatian No. 68 & 158, Dag No. 1, P.S. Onda, District Bankura.

One Amrit Hatcheries Pvt Ltd owned approximately 32.28 acres of the land comprising of 3 plots being nos. 390, 392 and 396 at Mouza Ambari Hazarigram, Khatian Nos, 219, 4248, 391, 377/21/118, 222, 266, 334, 192, 149, 39, 450, 318, 107/114/370, P.S. Onda, District Bankura. Amrit Hatcheries used to run a poultry farm on such land. It is pertinent to mention here that the land owned by Amrit Hatcheries is adjacent to Rowland Tracom's land.

Thereafter, we heard that there were certain disputes going on in respect of the Amrit Hatcheries properties. However, Rowland Tracom is in no manner connected to either the land onwed by Amrit Hatcheries or the alleged dispute.

On or about 14/11/2019 i.e. Thursday night at about 11.45 pm, the employees/officers/guards of Skylark Feeds in furtherance of some evil conspiracy, taking advantage of the fact that it was almost midnight and therefore no one will notice, illegally tried to dispossess us from our property using force and unlawful means. The accused persons, forcefully and illegally entered into our property. When we objected, the employees/officers/guards of Skylark Feeds threatened us with dire consequences. We also requested them to show us title deeds and documents through which they were wrongly claiming right over of our property. However, the accused persons failed to provide any such document. Despite all their attempts

they could not force us out of our legal possession. As per further enquiry made us, we have learnt that Skylark Feeds has now lodged a false and concocted complaint before your good office wherein they have made bald and reckless allegations against the employees of Rowland Tracom Pvt Ltd. We apprehend that Skylark Feeds through its officers/guard/employees will use all their might to cause wrongful loss to our life and property. The lives of the employees of Rowland Tracom Pvt Ltd who are staying at the said property and enjoying peaceful possession of their property is at grave and serious threat from the accused persons.

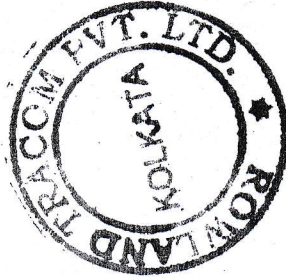
In light of the same, I would most humbly request you to take necessary and appropriate action against the wrongdoers at the earliest.
