I Sri Abhishek Rai S/O-Sri Vijay Prakash Rai, AE & Station Manager of the Patrasayer Customer Care Centre, WBSEDCL being authorized under the Electricity Act.-2003 and Electricity (Amendment) Act-2007, do hereby lodge complaint against user accused, JHANTU PAUL, S/O- LT. LALMOHAN PAUL Vill-SONATHIKRI, P.O.-PARULIA , P.S- Patrasayer, Dist- Bankura for theft of electricity by direct hooking with the help of hooking device from nearby L.T. O.H line of WBSEDCL, U/S.- 135(i) (a) of Electricity Act 2003 and Electricity (Amendment) Act-2007, as Stated here under:-

That on 21.11.2019 in between 3:45 p.m. and 4:00p.m Myself along with Ranajit Barua(SAE), Joydeb Roy(TSH), Nepal Chakraborty (HG LM) of Patrasayer CCC, S & LP team, Bankura and others, on the basis of secret source information inspected the Domestic premises of user accused, JHANTU PAUL, S/O- LT. LALMOHAN PAULVIII-SONATHIKRI, P.O.-PARULIA, PS-Patrasayer, Dist- Bankura and during inspection it was found that user accused JHANTU PAUL were using electricity unauthorizingly and dishonestly in his Domestic premises by direct hooking from nearest LT mains of WBSEDCL with the help of two nos single core PVC cable found one end in bend condition to use as hooking device. So, he has committed theft of electricity and liable for prosecution U/S.-135(i) (a) of Electricity Act-2003 and Electricity (Amendment) Act-2007.

I directed Ranajit Barua (S.A.E) to prepare the inspection report on the spot and assessed the load which comes to 0.3 KW. I directed Nepal Chakraborty to dehook the hooking cable fitted with ETOH line of WBSEDCL . He accordingly dehooked the same and Ranajit Barua(SAE) seized the same and seizure list was prepared accordingly. Copy of Seizure list and Inspection report could not be handed over to the accused person nor his representative refused to accept that. Although WBSEDCL provided him electrical connection vide con id 233075270 which was already in disconnected and deemed position for osd in our system database.

The inspection team left the site at 4.05 p.m hrs on **21.11.2019** after completion of inspection & raid. It is well proved that user accused JHANTU PAUL, S/O- LT. LALMOHAN PAUL VIII-SONATHIKRI, P.O PARULIA, P.S-Patrasayer, Dist- Bankura vide Con Id: 233075270 committed theft of electricity by direct hooking from nearby LTOII line of WBSEDCL as such he is liable for prosecution u/s 135 (1)(a) of Electricity Act 2003 amended in 2007.

So you are requested to treat this complaint as F.I.R.
