Dear Sir,

I, Sri Biswanath Barui, S/O- Sri Swadesh Ranjan Barui, AE & S.M, Raipur CCC, WBSSEDCL, being authorized under the Electricity Act 2003 and Electricity Act (Amendment) -2007, do hereby lodged complaint against accused **Sri Rohini Mondal , C/O- Tulsi Mondal residing at Vill- Sarigari, P.O.- Motgoda, P.S.- Raipur, Dist-Bankura, Pin- 722134** who was committing theft of electricity by direct hooking from nearby LTOH line of WBSSEDCL for the electricity energy consumption of his **domestic** purpose.

Following a secret source information on **15.11.2019** between **12.40hrs to 12.55hrs**, I along with 1) Sri Manoranjan Hazari, S/O- Bangshi Hazari L.M., 2) Sri Harisadhan Karmakar, S/O- Lt. Indrajit Karmakar Sr. TSH attached to Raipur CCC, WBSSEDCL inspected the **domestic** premises of accused **Sri Rohini Mondal , C/O- Tulsi Mondal residing at Vill- Sarigari, P.O.- Motgoda, P.S.- Raipur, Dist-Bankura, Pin- 722134**. During inspection it was detected that said accused person was committing theft of electricity by direct hooking from nearby LTOH line of WBSSEDCL.

The consumption load which was detected as **0.8 KW** by the Inspection team and accordingly the inspection report was prepared. I directed Sri Manoranjan Hazari, L.M, Raipur CCC to de-hook the hooking cable from LTOH line of WBSSEDCL and he did the same which I seized 01 no 2 core PVC cable approx length 15 feet as a sample basis after preparing seizure list.

It is well evident that the accused person was committing theft of electricity by direct hooking from nearby LTOH line of WBSSEDCL as such he is liable for prosecution u/s 135(1)(a) of Electricity Act 2003, Amendment in 2007. Kindly treat this complaint as F.I.R.
