

Sub: Prayer for starting a cog- case under specific section of law against accused i) Prabodh Mondal @ Laltu Mondal (32) S/O- Pareshnath Mondal of village Barul P.O- Birkuti P.S- Jamuria Dist- Paschim Bardhaman ii) Krishna Gorai @ Bablu @ Radha (35) S/O- Lt. Aloke Gorai of village Ampahari ,PS- Chhatna , Dist- Bankura, Presently residing at Bangalpara, 4 No. Dalurbandh, P.S- Pandabeshwar Dist- Paschim Bardhaman .

Sir,

In producing herewith the following arrested accused, persons namely, i) Prabodh Mondal @ Laltu Mondal (32) S/O- Pareshnath Mondal of village Barul P.O- Birkuti P.S- Jamuria Dist- Paschim Bardhaman ii) Krishna Gorai @ Bablu @ Radha (35) S/O- Lt. Aloke Gorai of village Ampahari ,PS- Chhatna , Dist- Bankura, Presently residing at Bangalpara, 4 No. Dalurbandh, P.S- Pandabeshwar Dist- Paschim Bardhaman , along with (1) two (02) numbers of seized fire arms, (2) three (03) numbers of live ammunitions, (3) one Motor Cycle bearing registration number WB40AM/6850 (4) One cotton hand Bag (5) One Iron-rod of which one end is pointed and other end is flat, (6) One old printed bed-shit (7) Two old torn pieces of share, hand stitched together for using it as shawl (8) One Chocolate –Brown colour old muffler . I, ASI Anup Mukhopadhyay of Jhantipahari O.P under Chhatna PS would like to lodge a complaint against the aforesaid two accused persons to the effect that today, as per order, myself left for performing local night mobile duty within P.S. area alongwith (1) C/553 Sudarshan Majhi (2) C/1091 Ramshankar Middya (3) NVF/748 Karali Goswami all of Chhatna P.S vide Chhatna PS C.C.No-2841/19 dtd:- 03/12/2019. This refers Chhatna P.S GDE No 117, dt 03/12/2019.

In course of performing the said duty, I received a telephonic information from OC Chhatna PS at about 02:08 hours hrs regarding an incident of theft of two numbers of TOTO from Malirdanga village under Chhatna 1 GP, PS Chhatna and at once I briefed the matter amongst my force and started moving here and there with searching eyes. At about 06:05 hrs I along with force reached on the Chhatna Susunia metal road just in- front of Youth Hostel under Susunia G. P, PS Chhatna and found that the aforesaid two accused persons were coming towards Susunia under Chhatna PS from Kusthal side under GGhati PS riding on a Red & Black colour Motor Cycle along Mejia Chhatna main pitch road via Susunia. We tried to stop them showing hand-signal but they denied the signal and dodging the police party tried to flee, and we chased them from their back side. After some-time of chasing they tried to flee away from the spot after shove off the Motor Cycle on the metal road. Then after a strong chasing I and my force were able to apprehend both of them. On being asked they could not give any satisfactory answer as to why they tried to flee and kept mum. On suspicion we searched both the accused persons one by one very carefully and recovered the following articles from their possession -

From accused Krishna Gorai @ Bablu @ Radha

(1) One improvised fire-arms having total length approx 10" (inch) from end of the Butt to top of the Barrel.

- One round of 8mm live ammunitions.
- One mobile phone styled as "oppo"

Seized article number sl no (1) was recovered from the right side waist of the accused kept in concealed condition underneath of his pant and seized article sl no (2) was loaded inside seized article sl number (1).

From accused Prabodh Mondal @ Laltu Mondal

- (1) One improvised Fire-Arms having total length 9.5 " (inch) from end of the Butt to top of the Barrel.
- (2) One round of live ammunition
- (3) One round of live ammunition
- (4) One cotton hand Bag
- (5) One Iron rod of total length 22'(inch) of which one end is pointed and other end is flat.
- (6) Two old pieces of Sharee hand stitched together for using as shawl.
- (7) One Chocolate Brown old Muffler.
- (8) One printed Bed-shit.
- (9) Two mobile phones (one styled as "itel" & another styled as "micromax")

Seized article sl number (1) was recovered from the left side waist of the accused kept in concealed condition underneath of his pant. Seized article sl number (2) was loaded inside seized article sl number (1), seized article sl number (3) was found in the right side pocket of pant of the accused, seized article sl number (4) was recovered from the possession of the accused person and seized articles sl number (5),(6),(7) & (8) were found in wrapped condition inside seized article sl number (4). Details in seizure list.

I asked them as to why they had been carrying these incriminating articles but they could not give any satisfactory answer and simply kept mum. On being asked they failed to produce any valid documents in respect of above noted articles and the Motor Cycle also. I ought to have seized their wearing apparels; but it was not possible at that time. So, I did not seize those. I seized all the above noted articles as noted above along with the Motor Cycle bearing registration NO- WB40AM/6850 under proper seizure list being duly signed by the accused persons as per seizure list. As there were no local people due to such early hours of the day, I took the signature of my accompanying forces in the seizure list and also prepared proper labels. After that, I arrested them consecutively, observing all formalities of arrest and guidelines of NHRC and the Honble' Apex Court and also issued them memo of arrest and stated them the reason of their arrest. The process of search, seizure and arrest got completed in between 06:25 hrs and 07:45 hrs.

Under the above circumstances, I pray before you to start a cog case under proper section of law against the above noted two (02) arrested accused persons.
