Sir,

In producing herewith one arrested accused person namely Aswini Mandal (55) S/O- Lt. Khandu Mandal of Village-Simulberia, PS- Chhatna, Dist-Bankura along with seized articles respectively (1) 08 no's of Sealed plastic bottles of Country Sprit style as "DIL SE" (600 ml each), @ Rs- 35/- each. (2) 12 no's of Sealed plastic bottles of Country Sprit style as "DIL SE" (375 ml each), @ Rs- 22/- each. (3) One white colour plastic Jarican of 10 ltrs. contained approx 06 ltrs. ID Liquor (@ Rs.125/ per litter), from which 375 Ml. ID liquor taken as sample in a empty bottle under proper seizure list; with original seizure list and beg to report that in course of my mobile duty today on 23.12.19 at about 18.35 hours. I received secret telephonic information that a person is selling liquor in his Grocery shop namely Aswini Mandal at Simulberia village under Chhatna PS. I informed the matter to O/C Chhatna PS, as per his direction myself along with Const/565 Shibaram Mishra, Const/1469 Tarapada Mondal & NVF/336 Sadhan Guli rushed to the spot. On reaching there at about 19.25 hours we found that a person is engaged in selling liquor at his said Grocery. On getting the scent of police some person flee away from his shop and in spite of chase they narrowly escaped. We managed to apprehend the above noted accused person from his Grocery shop as on being search the above noted seized articles found from his Grocery shop. On being asked he could not produce any valid documents or receipt/Challan from any competent Govt. authority in support of his selling said liquor. I seized above noted liquors from the possession of the above noted accused person under proper seizure list duly signed by the accused person as well as police person, as none was available to sign the seizure list even his family members denied to sign on the seizure list. One copy of seizure list supplied to the accused person after arrest him by observing all legal formalities.

It is evident that the above noted accused person is liable to be prosecuted U/S 46 (A) BE Act.

So, I pray before you that a case may kindly be started against 1) Aswini Mandal (55) S/O- Lt. Khandu Mandal of Village-Simulberia, PS- Chhatna, Dist-Bankura under proper section of law and oblige.
