In producing herewith the following articles as single core PVC wire of length approx- 07 (seven) Mtr. with 01(one) no 100 W lamp seized under proper seizure list, duly signed by available witnesses, I MD Afroz Ahmad (35) S/O-MD Sayeed , Assistant Engineer & Station manager of Indpur CCC do hereby lodge complaint against Manjur Dalal(user), S/O Lt. Noormohammad Dalal, Vill: Dhuniagarh, PS: Indpur, Dist.: Bankura to the effect that today at 11.00 hrs acting on a tip-off, myself accompanied by Sumit Kumar Misra , Sr. SAE(E) and Saroj Kumar Biswas, Hr. Sr. LM, Indpur CCC with Sitaram Banerjee, S.O.(S& LP ), Bankura Regional Office had gone to Dhuniagarh village to work out the information. Around 11.25 hrs of date we reached at Village Dhuniagarh and inspected the electric line near the house of Manjur Dalal(user) for domestic purpose and during inspection it has been found stealing of electricity dishonestly at the premises of Manjur Dalal(user) by way of direct hooking from LT line and has caused financial loss to WBSSEDCL and the load is assessed as 200 W. The inspection team left the site at about 11.35 hrs.

Thus the owner cum Occupier Manjur Dalal(user) has violated the provision of section 135(1) (a) of Electricity Act 2003 (Amendment 2007).

Hence I seized the above noted articles under proper seizure list following disconnection the electric line by removing hooking device with the help of our technical staff and produce before you with a request to treat this complaint as FIR and initiate a case u/s 135(1) (a) of Electricity Act 2003 (Amendment 2007) against Manjur Dalal(user), S/O Lt. Noormohammad Dalal, Vill: Dhuniagarh, PS: Indpur, Dist.: Bankura and arrange for its investigation.
