Sir,

In producing herewith seized articles i.e. 1) one improvised country made fire arms loaded with 2) One round live like cartridge 3) One old nylon bag along with seizure list in original duly signed by the witnesses. I beg to report that, today (23.12.19) at about 17:35 hrs while I was performing mobile duty along with C/1754 Sanjib Pal, NVF/0596 Subhendu Sinha Mahapatra vide CC No-4414/19 Dated-23.12.19. I received an information one reliable source that one person wearing a dark woollen sweater and jeans pant, about 5 feet 06 Inches height moving suspiciously with one improvised fire arms at Lagadih area. On receiving of the information I informed to I/C Sarenga P.S. regarding this matter and as per order, myself along with force rushed to the spot to verify and work out the information. On arrival at Lagadih near spot/PO found one person was moving suspiciously. The person was identified by my source. We proceeded towards him. Getting the smell of Police he began to run towards Khamani Jungle and throwing one bag in the bush, he fled way. The Police party tried to apprehend the person but he managed to escape from the spot. The Police party recovered the bag from the bush and I found 1 (one) shutter fire arms, having its trigger, hammer, firing pin, butt, barrel and loaded one round live like cartridge. I seized the same under proper seizure list and labelled in presence of witnesses duly signed by them.

Considering the facts & circumstances, I therefore pray for starting a specific case under proper section of law against unknown person and arrange for its investigation.
