Sir,

I, Sri Sushanta Garai, S/O Sri Anil Garai, A.E. & Station Manager of Indas C.C.C. of WBSEDCL do here-by lodge complaint against accused Prasenjit Jash, S/o Kirty Bhusan Jash of village Habispur & P.O- G Bannia, P.S- Indas, Dist.- Bankura for committing theft of electricity by hooking arrangement from the LTOH line of WBSEDCL for the purpose of his domestic premises.

Receiving the information from reliable sources, between 13.50 hour to 14.05 hours, I, Sri Sushanta Garai, AE & SM of Indas CCC, along with Sri Utsa Dey, S/o Mr. Alope Dey, S.A.E Indas CCC and S&LP team, Bankura Regional Office WBSEDCL, Sri Loknath Das, Sr. TSH, S/o Late Sunil Ranjan Das of Indas CCC and technical person of mobile van of Indas CCC inspected the premises of said accused person upon serving notice to him. During inspection it was detected that the said person was committing theft of electricity by means of direct hooking from WBSEDCL LTOH line. From inspection, it was also found that an existing service connection with installed WBSEDCL meter no. DDT1132788 in the name of Kirty Yash having consumer ID 200037011 was present. The said meter was not utilized fully for consumption of entire premises but only a part thereof and rest of the part of the premises was running on hooked line.

I prepared inspection reports and assessed the consumption of load which was detected as 0.20 K.W.

I directed Sri Loknath Das to remove the hooking wire from the LTOH line and also to disconnect the service line of Kirty Yash from pole side. Accordingly with the help of mobile van staff, he did the same.

I seized the portion of hooking wire of the accused as a sample by preparing seizure list and left the premises with the inspection team.

It is well evident that the said accused person was committing theft of electricity as such he is liable for prosecution w/s -135(1) (a) of Electricity Act-2003, Amended in 2007.

Kindly treat this complaint as FIR.
