

Sub: Prayer for lodging FIR against Sukumar Bauri.

Sir,

In producing herewith the arrested accused namely Sukumar Bauri (50 Y) s/o-Lt. Arun Bauri of village- Bon Birsingha, P.S- Patrasayer, Dist- Bankura with following seized articles under proper Seizure List.

I, SI Shyamalendu Chowdhury of Patrasayer P.S beg to inform you that today at about 04:05 hrs during night mobile duty received secret information that one Sukumar Bauri (50 Y) s/o- Lt. Arun Bauri of village- Bon Birsingha, P.S- Patrasayer, Dist- Bankura has manufacture a huge quantity of illegal, I.D liquor for selling in his house which is situated at Bon Birsingha Village under Patrasayer P.S, Dist-Bankura. Informed the matter to In Charge Patrasayer P.S and as per direction of In-Charge Patrasayer P.S, I along with force in proper Police uniform reached at the said Village to work out the information. We reached at Bon Birsingha at about 04:35 hrs and as identified by secret source, reached in the house of Sukumar Bauri (50 Y) s/o- Lt. Arun Bauri. Seeing police some persons fled away from the house. During search at the house of Sukumar Bauri, we found 02 (Two) plastic jariken containing approx. 20 liters of colourless liquor having strong smell of I.D liquor in each jariken. Being asked the owner of the house Sukumar Bauri (50 Y) s/o- Lt. Arun Bauri of village- Bon Birsingha, P.S- Patrasayer, Dist- Bankura failed to produce any kind of document or license in respect of manufacture and selling I.D liquors and admitted that he is running such business from his house since long without any license. So, I seized 40 (forty) litter of colourless liquor having strong smell of I.D liquor in 02 (Two) plastic jariken stored in his house after preparing proper seizure list duly signed by the witnesses. Seized articles were sealed and labeled at the spot in between 04:55 hrs and 05:25 hrs. Collected as Sample one bottle from each jariken with seal and label duly signed by witnesses as well as the accused person. Thereafter, I arrested the accused Sukumar Bauri (50 Y), s/o- Lt. Arun Bauri of village- Bon Birsingha, P.S- Patrasayer, Dist- Bankura after maintain all rules and regulations as directed by the Apex Court and NHRC. Issued Memo of Arrest with proper signature duly signed by the accused person and took my custody.

Under the above circumstances, I request you to start a specific case against the accused Sukumar Bauri (50 Y) s/o- Lt. Arun Bauri of village- Bon Birsingha, P.S- Patrasayer, Dist- Bankura under proper section of law and arrange for its investigation.
