In producing herewith the following articles: (1) PVC two core cable length in about 20 feet, seized under proper seizure list duly signed by available witnesses, I Sri Uttam Kumar Das (SI) s/o Sri Indranarayan Das, AE & SM of Sonamukhi CCC do hereby lodge complaint against Madhusudhan Patra c/o Lt Shakti Patra of village: Rampur, PO: Hamirhati, PS: Sonamukhi, Dist: Bankura to the effect that today at 12:30 hours acting on a tip-off myself along with Sri Hare Krishna Sau O.E.s/o Lt Subal Chandra Sau, Chandradeb Khetrapal, HG. TSH s/o Lt Renu Pada Khetrapal both of Sonamukhi CCC and Sri Sitaram Banerjee, S.O. S&LP of Bankura Regional Office, WBSEDCL, Bankura had gone to Rampur to work out the information and during inspection about 13:10 hours the occupier/ owner Madhusudhan Patra has been found stealing electricity dishonestly at his premises for his domestic purpose by way of direct hooking from nearest LT Overhead line of W.B.S.D.C.L. and has caused financial loss to WBSEDCL and the load is assessed 0.250 KW. Since the owner cum occupier of the premises was not present at the time of inspection and detection of the commission of offence. I fixed the responsibility as well as the owner cum occupier of the land on which the offence done with the help of my source.

Thus the owner cum occupier of the premises has violated the provision of section of 135 (1)(a) of Electricity Act-2003 (Amendment- 2007).

Hence I seized the above articles as mentioned above under proper seizure list duly signed by available witnesses following disconnection the electric line by removing hooking devices and produce before you with a request to initiate a case u/s 135 (1)(a) of Electricity Act-2003 (Amendment-2007) against Madhusudhan Patra c/o Lt. Shakti Patra of Village: Rampur, PO: Hamirhati, PS: Sonamukhi, Dist: Bankura and arrange for its investigation.

The result of the investigation may kindly be communicated after the investigation is over for onward action.
