Sub: Complain against accused Jadab Dey, S/O Panchanan Dey, Vill.- Roll, Uttarakhanda, P.O- Roll, P.S.- Indas, Dist- Bankura for theft of electricity by direct hooking from O/H LT line of WBSEDCL for charging Toto Rickshaw.

I, Sushanta Garai, S/O- Anil Garai, AE & SM, Indas CCC, WBSEDCL, being authorized under the Electricity Act, 2003 and electricity amendment Act, 2007, do hereby lodged complaint against accused Jadab Dey, S/O Panchanan Dey, Vill.- Roll, Uttarakhanda, P.O- Roll, P.S.- Indas, Dist- Bankura, who was committing theft of electricity by direct hooking from nearby LTOH line for charging Toto Rickshaw in front of his domestic premises.

Following secret source information on 07.02.2020 between 15.45 hours to 16:20 hours I along with Sri Utsa Dey SAE (E), Indas CCC, Tapas Kr. Mishra, TSH, Indas CCC, Sri Soumava Das, Assistant Manager (HR& A), Harun Al Rashid, Assistant Engineer (IT & C) others technical staff attached to Indas CCC inspected the site premises of accused Jadab Dey. During inspection it was detected that the said accused person was committing theft of electricity by direct hooking from nearby LTOH line of WBSEDCL for charging his Toto Rickshaw in front of his domestic premises.

The connected load is assessed as 0.48 KW by the inspection team and accordingly the inspection report was prepared. Then I advised our technical staff to disconnect the unauthorized electric connection. After that I have seized the hooking materials and prepared the seizure list duly signed by him and left the premises along with the inspection team.

It is well evident that the accused person was committing theft of electricity by direct hooking from nearby LTOH line of WBSEDCL as such he is liable for prosecution U/S 135(1) (a) of electricity Act, 2003, amended in 2007.

Kindly treat this complaint as FIR.


