Sub : - Prayer for lodging of F.I.R against Kalyan Singh (53Y) S/o Lt. Jagabandhu Singh of Bothkula, P.S Indpur, Dist. Bankura.

Sir,

In producing herewith arrested accd. namely Kalyan Singh (53Y) S/o Lt. Jagabandhu Singh of Bothkula, P.S Indpur, Dist. Bankura along with seized 17 (Seventeen) bottles of Country spirit in every of which a sticker is affixed on it written "DIL KHUSH"- Country spirit, measure--375 M.L, MRP—Rs. 25/- each, strength—80 UP", 11 (Eleven) bottles "Bullet"- Country spirit MRP—Rs. 85/- each, measure---600 ML strength—60 UP & 20 (Twenty) liters (approx) I/D Liquor in a plastic jar (Total value of seized country spirit Rs-1360/-) as per seizure list and submitting a written complaint against the aforesaid accused person to the effect that today ie on 02.03.20, after receiving a secrete source information vide Indpur PS GD No. 66 dtd. 02.03.20 and as per direction by Indpur PS duty officer myself ASI Bikash Mandal , along with C/1760 Subir Dey, C/1366 Samir Kr Roy & NVF-Bapi Chand all of Indpur PS, in course of mobile duty at about 17:25hrs.held raid at Dangarampur Goswami More and found the above noted accused person is selling Country Sprit & I/D liquor in his Tailor Shop . On being asked he failed to give any satisfactory answer and failed to produce any valid documents for consuming and selling Country Sprit, & I/D liquor and started shouting against police. Then I seized the above noted Country Sprit & I/D liquor from the possession of above noted accused under proper seizure list and took up sample & labelled duly signed by the accused and witnesses. During seizure none could agree to signed the seizure list as witness due to fear of above noted accd. Person. So I seized the same as per proper seizure list duly signed by Police witness as well as accd. Person. Finding no other alternative way, I arrested him after observing all legal formalities of arrest rules. On interrogation he confessed that he had stocked those bottles of Country spirit & plastic jar of I/D liquor with a view to sell the same to the local customers with high price without any permission from legal authority. Thereby he violated Bengal Excise Act.

I, therefore, pray that a case u/s 46 A of Bengal Excise Act may kindly be started against the above noted accused person and arrange for its investigation.
