After a few months later on 16.03.2020 she came to my branch Chingani (UBI) for cash withdrawal but due to non submission of KYC documents, she could not withdraw the amount.

On the very next day that is 17.03.2020 her father Mr. Nurbakt Khan came to the branch and abused me and threat for bad consequences.

After closing the branch on dated 17-03-2020 when I was returning to my residence, Mr. Nurbakt Khan along with some people attacked, pushed and kicked me, pulled up me with my collar and snatched my golden chain man chingani bus stand.

Some how I returned to my residence. therefore I am suffering from syrosis after the incidence.

Therefore you are requested to take necessary measures at your earliest.
