Sir,

In reference to the above subject this is to inform you that we have received one application from Shambu Mukharjee and others of HT maintenance team of New Bishnupur 220/132/33/11 KV Sub-Station. Where it has been stated that as on 22.04.2020 when the team included with Sambhu Mukharjee(skilled), Asis Pal(Un-skilled), Ganesh Maji(Un-skilled), Avijit Mandal(Un-skilled), Rabi Roy(Un-skilled) and jayanta Mukharjee(Driver) was returning after completion of fuse call from Lakhasol under Radhanagar 11 KV feeder emanated from New Bishnupur 220/132/33/11 KV Sub-station. When they have reached at Radhanagar Bazar at about 17.00 hrs on that day two people namely 1. Bibek Dhara, S/O-Durga Dhara, Radhanagar Bazar, PO-Radhanagar, PS-Bishnupur and 2. Haru Layek, S/O-Jaba Layek, Radhanagar Bazar, PO-Radhanagar, PS-Bishnupur stop the car and attack on them and started physical torture on them and use slang language and threatened them to murder. And they specially attack on Samuhu Mukharjee and Asish Pal and use intolerable language against them. After some time they somehow manage to escape from this place after almost half an hour.

This maintenance team engaged to provide better power supply to the area under Radhanagar area. And when they are discharging their duty specially at that time when whole country under lockdown situation due to out-break of Covid-19 but the maintenance team continue their duty to provide power supply to the consumers.

Therefore in this circumstance you are requested to cognizance on this matter and take necessary action as per law.
