Sub: - Prayer for lodging FIR.

I ASI Sudhir Kr Jana of Mejia Police station, Bankura do hereby lodge complain against 1. Jaydeb Khan S/o Somnath Khan of Vill Baktarngar Khapara PS Raniganj Dist Paschim Burdwan, 2. Soumen Mitra S/o Unkhown of Asansol -3 ADT Colony, 3. Bappa Paul S/o Kumaresh Paul of RN Colony Chicuria, Paschim Burdwan & Driver of the vehicle No -JH02S/6954 for illegal transportation and mining in and outside of state. On 25.05.2020 at 14:05 hrs received information from an unknown caller to the effect that, one truck bearing Regd No -JH02S/6954 (12 Wheeler Truck) loaded with coal will come from Raniganj Side without any valid documents. The truck illegally transports coal from outside of Bankura to any unknown place. Accordingly I informed the matter to O/C Mejia PS & Table officer for sending sufficient force at Mejia Bridge (Nakapoint). At 14:35 hrs one truck with excessive speed was coming from Raniganj side. Seeing no other option I along with Naka team consisting with CV Prasanta Maji, CV Sourav Mondal, CV Abhijit Sadhu, CV Srimanta Ghosh, CV Madhusudhan Chakraborty Vide GDE No-1016 Dated- 25.05.2020 and Mobile Team officer ASI Uttam Kr Mondal along with C/532 Shibshankar Chatterjee, C/775 Harendranath Bauri, NVF- Bapi Sardar vide CC No- 1170/2020 Dated - 25.05.2020 & GDE No- 1010 Dated- 25.05.2020 putting the guardrails and road barriers for intercepting the said truck. Seeing no other option the driver of the truck stopped the truck in front of Mejia PS Naka on NH-60, Raniganj- Mejia Road.

On being asked the driver of the vehicle produced one weight certificate and perused the certificate loaded with 30.100 MT of coal as per challan. During the checking I also asked about the whereabouts of the coal along with its source and the involved persons who are demising the national property with fraudulent manner. The driver of the vehicle stated that 1. Jaydeb Khan S/o Somnath Khan of Vill Baktarngar Khapara PS Raniganj Dist Paschim Burdwan, 2. Soumen Mitra S/o Unkhown of Asansol -3 ADT Colony, 3. Bappa Paul S/o Kumaresh Paul of RN Colony Chicuria, Paschim Burdwan are involved with illegal mining and fraudulent transportation from Paschim Burdwan to outside of state. I again asked about the whereabouts of the above said persons as well as the owner of the truck and the destination of the illegal coal, He stated the above noted information about the involved persons and supplied few papers in a irregular manner and jump from the truck and fled away towards raniganj side through damodar river. I along with ASI Uttam Kr Mondal and force gave a hot chase but could not able to catch him.

Therefore I seized the vehicle along with loaded coal amounting 30.100 MT as per challan, with a view to submit complaint against the culprits for starting a specific case as per law.

Thus it is reasonably believed that the above noted persons namely 1. Jaydeb Khan S/o Somnath Khan of Vill Baktarngar Khapara PS Raniganj Dist Paschim Burdwan, 2. Soumen Mitra S/o Unkhown of Asansol -3 ADT Colony, 3. Bappa Paul S/o Kumaresh Paul of RN Colony Chicuria, Paschim Burdwan & Driver of the vehicle No -JH02S/6954 are selling and transporting coal illegally and clandestine way. So a specific case U/S- u/s 379/413/414/120B IPC and 30(2) CMN Act and 21 Mines and Minerals (Development & Regulation) Act, 1957 may kindly be started against them.
