- 3) that, or someone will sell my daughter for prostitution.
- 4) that or my daughter has been forcibly abducted, detained or tortured by some one.

From my above guess I, therefore request you, let be created my written complaint as F.I.R. and if you kindly help me to rescue my daughter from her great critical situation. I shall be grateful to you for all time to come.
